Re: OPRA Request – Daniel McDonald and Tricia Jaccoma

The above-captioned request, received by the Monmouth County Prosecutor's Office on June 20, 2020, was for records described as follows:

1. Copies of any police CAD report(s) with narrative(s), mug shot(s), arrest report(s), affidavit(s) of probable cause against defendants Daniel McDonald, 25, and Tricia Jaccoma, 24.

Timely response would be due June 30, 2020.

Provided with this letter are responsive documents:

- Affidavits of Probable Cause with driver's license and telephone numbers redacted pursuant to N.J.S.A. 47:1A-5.
- Arrest reports for Mr. McDonald with driver's license, phone, and social security numbers redacted pursuant to N.J.S.A. 47:1A-5. Military status is redacted pursuant to N.J.S.A. 47:1A-9 and R. 1:38-7(a). Photo of the defendant is redacted in accordance with N.J.S.A. 47:1A-9 and Executive Orders 9(e) (Hughes), 69 (Whitman), and 21 (McGreevey).
- CAD abstract with phone numbers redacted in accordance with N.J.S.A. 47:1A-5, and vehicle registration number redacted in accordance with N.J.S.A. 47:1A-9 and R. 1:38-7(a). Also redacted in blue is narrative on pages 1-2 of the report, as such pertains to a criminal investigation and is exempt from release under the "criminal investigatory records" exception. N.J.S.A. 47:1A-1.1; North Jersey Media Group, Inc. v. Township of Lyndhurst, 441 N.J. Super. 70, 105-07 (App. Div. 2015), rev'd on o.g., 229 N.J. 541, 569 n.6 (2017).

The request for mug shots is denied. As indicated above, a mug shot is exempt from disclosure pursuant to N.J.S.A. 47:1A-9 and Executive Orders 9(e) (Hughes), 69 (Whitman), and 21 (McGreevey), which apply to "Fingerprint cards, plates and photographs and other similar

criminal investigation records which are required to be made, maintained or kept by any State or local governmental agency." (emphasis added).

Arrest report for Ms. Jaccoma is denied for lack of responsive record.
