Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

PO Savastano, SLEO II Brahn and Patrols responded to 1202 10th Ave for report of two male subjects fighting with weapons (bat vs. field hockey stick). Patrols made contact with Daquann Beerman who was holding a silver baseball bat and Myshon McKinnon who was yielding a purple field hockey stick. SLEO II Brahn observed both subjects actively assaulting each other with said weapons. SLEO II Brahn was subsequently spit on by Beerman while she was attempting to break up the fight. SLEO II Brahn stated Beerman spit on her face making contact with her mouth. Beerman proceeded to flee the area on foot after being told he was under arrest but was ultimately caught prior to entering the residence at 1202 190th Ave. McKinnon stated the fight ensued after he confronted Beerman about an undisclosed inappropriate social media post on Facebook. McKinnon added Beerman struck his vehicle with a bat causing a dent on the hood. No damage was observed and Beerman was advised of the complaint process. Furthermore, Beerman denied spitting on SLEO II Brahn. Neither subject had any physical signs of injuries and refused first aid on scene. Digital photographs of the weapons were taken and submitted to the NTPD ID Bureau as evidence. Beerman and McKinnon were placed under arrest transported to HQ and processed.
