Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

The accused was observed driving in a reckless manner, while having a suspended NJ Driver's license. PO Haskins activated his emergency lights and sirens to affect a motor vehicle stop. The accused fled the area at a high rate of speed failing to stop. After a short distance PO Haskins lost sight of the accused. He was then observed at W. Lake Ave. and Taylor Ave. outside of his vehicle. PO Haskins and PO Layton exited their vehicle and placed him under arrest. He was handcuffed behind his back and searched. While being escorted to marked patrol vehicle #3 for transport to headquarters the accused kicked the right rear quarter panel of the patrol car causing a dent and damage. The vehicle was being operated by PO Yurman. The vehicle he was operating was a 2020 Honda, which displayed an expired NJ Temporary registration. The vehicle was held for forfeiture. While securing the personal property in the vehicle a NJ license plate [REDACTED] was recovered. This license plate was reported stolen in the City of Newark on 5/21/2020. The accused was processed at headquarters.
