Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On 07/21/2020 at approximately 01:15 hours I was dispatched to assist Brielle PD on Rt 35 near Evergreen Ave for a report of a suspicious vehicle. Upon arrival it was Sgt Norcia, Ptl Tantum and I, Brielle PD was not on scene due to being on another call. I observed a white Mercedes Benz to be unoccupied in the southbound shoulder of Rt 35. Sgt Norcia advised me that the vehicle which bore NJ registration [REDACTED] was possibly a vehicle that Brick PD had been looking for due to a prior incident earlier in the evening. While making sure no individuals were located in the vehicle I detected a strong odor of suspected marijuana emanating from the vehicle. While on scene Ptl Tantum advised me that he heard what appeared to be someone talking in the wooded area directly to the south of where the vehicle was located. Ptl Tantum and I drove to Higgins Ave which is the street that runs parallel to Rt 35, directly to the south. Upon arriving on Higgins Ave in the area of where we had heard someone speaking I observed the defendant sitting on a bench with a red duffle bag slung on his shoulder. Due to no one else being in the area and the time of day I stopped and spoke to the individual to attempt to ask if he knew anything about the suspicious vehicle. I asked the individual if he had any identification on him which he provided. When I first approached him I asked him to place his duffle bag off to the side, he did. When I was speaking with the defendant I detected a strong odor of marijuana emanating from his immediate area with no other individuals in the area. I advised the defendant that I would be searching him and his duffle bag that he had on his person due to detecting the odor of marijuana. He stated that he had marijuana on him. Subsequent to searching the duffle bag I located a loaded Smith and Wesson Bodyguard 380 semiautomatic handgun which had one round in the chamber with a magazine containing 13 more rounds. I also located 41 containers containing suspected raw marijuana and THC edibles, rolling papers commonly used to roll raw marijuana in to create a marijuana cigarette, approximately 12 bags which appeared to be used to package/store marijuana, and one other magazine clip that contained six .380 caliber rounds. As I inventoried the defendant's property I located nine fraudulent \$100 bills in his wallet which was removed off his person when he was placed under arrest.
