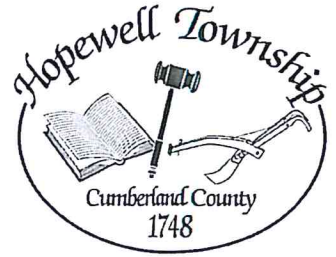

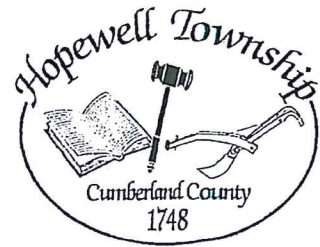

The South Jersey Scrub will be in its second year in 2019, with support from the NJDEP AmeriCorps Watershed Ambassador Program and NJ Clean Communities.

In 2018, PDE partnered with the Cumberland County Improvement Authority (CCIA) and the Salem County Clean Communities program to clean up six sites over two days, with 80 volunteers! This year, we are looking to expand the South Jersey Scrub to as many towns as possible, ranging from Trenton down to Cape May.

If your town would like to get involved and schedule a cleanup as part of the South Jersey Scrub, **please respond to this email so I can set up a meeting date with you.** Please respond by January 25th as we need to start picking out sites as soon as possible! If those dates do not work for you, let me know and I will be more than happy to figure out a different date for your cleanup.

Second, those of you who are registered with Sustainable Jersey – they have just released a PSEG Foundation sponsored grant for municipalities and schools to support efforts related to the Sustainable Jersey actions. If your municipality or any schools in your town would like to participate (or if you have any suggestions of towns or schools) **please respond to this email stating you are interested so we can set up a meeting date to discuss further the projects we can collaborate on!** The municipality grant is due February 15th and the schools grant is due March 15th

If there is anything else that I can provide my services for; if you are interested in presentations, other projects, or a training, please let me know. I want to serve my watershed as best as I can, and with your help, I believe I can make that possible!
