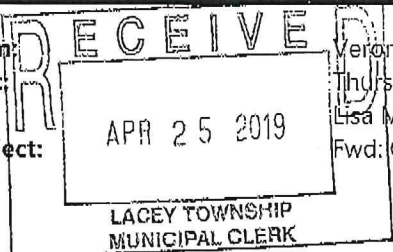

Narrative

On Tuesday, April 16, 2019, I responded to 402 Carr Street, Forked River, for a report of a suspicious incident.

Upon my arrival, I met with the caller Kathryn Lander. K. Lander stated she was on the Lacey Chatter Facebook page, when she observed a post from "Denise Pegg" at 2051 hours today. She stated Denise Pegg posted "So my significant other and I are contemplating fighting back against the scumbag breaking into cars every night. Tonight we will set our own trap if he should choose to victimize us once again. He armed with his glock & I with my .380. Not looking to harm him just teach him a lesson and turn him in. he'll probably need a change of underwear though. (Crying face emoji) Putting our SUV in the (attached) garage unlocked. Just going to wait in the dark. (Skeleton and gun emoji)". She stated she found that post disturbing and contacted this agency.

At headquarters, dispatch advised me that Denise Pegg had a resident address at 119 Serpentine Drive, Bayville. I contacted Berkeley Police Department and spoke with a dispatcher, who stated Denise Pegg, also goes by her maiden name Denise Capizzi. Berkeley PD sent a officer over to her residence, with negative contact. I attempted to contact D. Cappizzi via the phone, however she does not utilize that number anymore. I contacted D. Capizzi's ex-husband Joseph Capizzi, who stated he does not communicate with D. Capizzi, nor does he know any information regarding the Facebook post.

I then checked the areas of 411 Brandywine Avenue, 419 Steuben Avenue, 1813 Woodside Drive, and 2088 Crestwood Drive, which are all locations of recent car burglaries and made negative contact with D. Capizzi.

It should be known that in the comments below her post, a fellow Lacey Chatter "friend" stated "Don't you know she lives in Florida", to which D. Capizzi replied "No I'm here in Lacey, haven't you seen my Red Mercedes in town". A check of the CAD for a Red Mercedes, yielded negative results.

There is no further police action requested or required at this time.
