Patrols were dispatched to 420 Cross Rd. unit B14 for a report of an assault. Upon arrival, patrols spoke to the victim, Gary Hearn, who reported his roommate, Denise Stark, struck him with chairs, a table, and her fists. Hearn had visible signs of injury (Bleeding from underneath his left ear, back, swelling on his left arm, and complaint of pain in his head and complaint of dizziness). Stark was placed under arrest for aggravated assault and possession of a weapon with an unlawful purpose.
