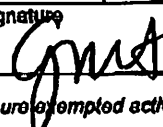

Dear Mr. Voorhees:

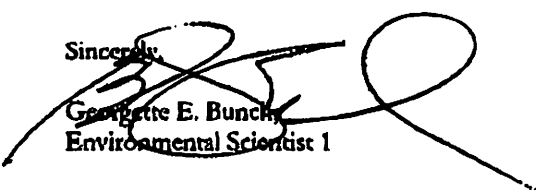
The New Jersey Department of the Treasury will be performing an emergency removal of asbestos containing pipe insulation in the Basement Mechanical Room of the Health and Agriculture Building on Friday, March 30, 2018. Originally asbestos repair work was scheduled for that date, but was amended to include the removal of a two foot section of pipe insulation when a leaking valve was discovered on the domestic hot water line. If the valve is not repaired, hot water cannot be safely supplied to the building without potentially creating a safety hazard.

Environmental Connections will oversee Abate Tech Inc. during the removal and repair process as well as collect pre and post air monitoring.

By way of this letter, the New Jersey Department of the Treasury, Division of Property Management and Construction (Treasury) is requesting a waiver of the 10 day notification to allow us to begin the asbestos removal and repair on Friday, March 30, 2018. This waiver will allow Treasury to make the necessary repairs to the domestic hot water line as soon as practicable.
