any and all (1) recordings of calls made to 911 and to non-emergency services, (2) copies of any and all police reports filed, and (3) any and all body worn camera ("BWC") audiovisual recordings made in relation to any Department activity at 138 Porter Ave in Seaside Heights, NJ on and after 07-January-2024 until and including 31-January-2024

The following is a line-by-line response to your requested items.

A. Requested records
