NARRATIVE On 11/2/20 at 1622 hrs, while traveling NB on Rt. 130 I observed an Amazon delivery van parked on the SB shoulder, south of Jackson Street. Unsure of why the van was stopped there, I pulled over onto the NB shoulder to see if I could tell what the driver was doing. Moments later I observed a large box getting tossed out of the passenger side sliding door of the van into the woods. At that time I got turned around and pulled behind the vehicle, a blue 2020 Dodge Ram Promaster van, NJ / [REDACTED] I then made contact with the driver, Desmond Gould, [REDACTED] who after being questioned about the box being thrown from the van, stated he was discarding his feces into the woods. I then had Mr. Gould retrieve the box which turned out to be an Amazon delivery bin containing numerous opened Amazon packages. Mr. Gould then admitted that he didn't feel like making these deliveries so he decided to throw

them into the woods but first he opened them to see if they were anything worth keeping. Mr. Gould stated none of the items were anything he wanted and that he had no intention of coming back for them. Mr. Gould stated he works out of the Amazon at [REDACTED] and he was advised that I will be following him there to contact his boss. Upon arriving at Amazon, I contacted his boss William Lawson who is a delivery service partner for Amazon and owns Angel Transportation LLC, the van that Mr. Gould was operating. Mr. Lawson stated that Mr. Gould has only been driving for him a few weeks and he will have to track his past deliveries to see if customers have been reporting packages missing or not delivered or if this is the first time he has done this. He then gave officers consent to search the van for other packages but that search was negative.

I then spoke to Mitchell Virkler, warehouse manager at Amazon who assisted with inventorying the recovered property. The property included the following; (4) packs of Solimo Unisex Protective Underwear, (1) Brightown Ceramic Heater, Dixie Paperplates (300ct), Elizabeth Arden Eye Liner, Glad Paperplates (50ct), (1) Sunday Missal Religion Book, Lysol Toilet Bowl cleaner, Centrum silver (275 tablets), (3) HD Barley Max Pure Green Juice, (3) boxes of Act Dry Mouth lozenges, (3) boxes of Retaine Dry Eye relief and (9) opened Amazon packages all totaling \$380.51. All property was then photographed and turned over to Mr. Virkler. Mr. Gould was then placed under arrest and transported to HQ where he was charged with theft on summons # S2020000103, Illegal Dumping, LO 5-1989 on SC-004743 and Throwing Debris from a MV, 39:-4-64 on L-088418 and was released after processing. He was then transported back to Amazon to retrieve his personal vehicle and was advised not to return to Amazon without contacting his boss first. Case pending court on 12/17/20 in Superior Court, Woodbury.
