Re: *Open Public Records Act Request*

Dear Mr. Hobbs:

The City of Linden ("City") records custodian is in receipt of your Open Public Records Act ("OPRA") request dated September 25, 2025. Your OPRA request seeks the following:

*To better understand all perspectives of an incident that occurred, I am requesting info on the following:
Arrestee Details:*

*Date of Birth or Age: 39
Gender: Male
Incident ID: 25000391
Incident Date: 2025-01-03 00:00:00*

Arrest By: Linden PD

Please provide the following:

- 1. The lead narrative report.*
- 2. All supplemental officer narratives.*
- 3. Associated case files and arrest reports.*

The City conducted a good-faith search and identified 22 pages of records as responsive. Please note that the following reports are being withheld:

- 1. Linden Police Incident Report, Incident No. 25000391, Report No. 1, authored by Ofc. William Annunziato on January 3, 2025 (4 pages); and*
- 2. Linden Police Incident Report, Incident No. 25000391, Report No. 2, authored by Ofc. David Guzman on January 3, 2025 (3 pages).*

These records are exempt from disclosure in their entirety as they constitute "criminal investigatory records" within the meaning of N.J.S.A. 47:1A-1.1. See North Jersey Media Group, Inc. v. Twp. of Lyndhurst, 229 N.J. 541, 556 (2017). These reports are not required by law to be made, maintained or kept on file, pertain to a criminal investigation, and are being held by a law enforcement agency. The exemption continues to survive the conclusion of the investigation. See

Boyd v. Atlantic County Prosecutor's Office, GRC Complaint No. 2012-253 (2013); Scott v. Red Bank Police Department (Monmouth), GRC Complaint No. 2011-244 (2013); Janeczko v. NJ Department of Law and Public Safety, GRC Complaint Nos. 2002-79 & 2002-80 (2004).

Additionally, please note that redactions have been implemented to remove dates of birth, a social security number, personal telephone number, and driver's license number. N.J.S.A. 47:1A-1.1 (exempting that portion of any document which discloses "the month and day of birth, any telephone number, the social security number, or driver license number of any person" from the definition of a "government record"). Please note that home addresses were also redacted as OPRA exempts the following information from public access – "[T]hat portion of any document which discloses the home address, whether a primary or secondary residence, of any active, formerly active, or retired judicial officer, prosecutor, or law enforcement officer, or, as defined in section 1 of P.L.2021, c. 371 (C.47:1B-1), any immediate family member thereof. . . ." N.J.S.A. 47:1A-1.1. The City is unable to determine whether either of the citizens reflected in the enclosed records would satisfy this standard, and thus it redacted each of their home addresses as a precautionary measure.

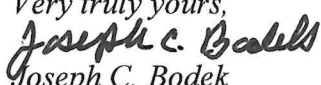
Please be advised that N.J.S.A. 47:1A-9a states that the provisions of OPRA shall not abrogate any exemption of a public record from public access heretofore made pursuant to . . . Executive Order of the Governor. Executive Order 26 (McGreevey 2002) provides in pertinent part:

The following records shall not be considered to be government records subject to public access pursuant to [OPRA] ... Information concerning individuals as follows ... Information relating to medical, psychiatric or psychological history, diagnosis, treatment, or evaluation[.]

Accordingly, redactions have been made to the responsive materials in order to protect the medical related information reflected in same.

Lastly, please note that Executive Order of the Governor No. 69 states, "[t]he following records shall not be deemed to be public records subject to inspection and examination and available for copying pursuant to the provisions of Chapter 73, P.L. 1963, as amended: fingerprint cards, plates and photographs and similar criminal investigation records that are required to made, maintained or kept by any State or local agency." See also Melton v. City of Camden, GRC Complaint No. 2011-233 (2013) (holding that photographs of individuals arrested are specifically exempt from disclosure). As such, the responsive records have been redacted to remove the arrestees' photographs.

Your OPRA request is now deemed answered and closed.
