Re: OPRA request dated November 19, 2017

To Whom It May Concern,

This office received your records request dated Sunday, November 19, 2017 via e-mail on November 20, 2017 and it was received by the records custodian on the same date. The last day to respond is December 1, 2017. You requested the following:

1. I seek your agency's Internal Affairs Annual Summary Reports for years 2014 to 2017.
 2. I seek a copy of the agency's Public Synopsis of Disciplinary Actions for years 2014 to 2017. This report is required pursuant to Requirement 10 of the Attorney General's Internal Affairs Police.
 3. I seek a copy of the agency's Vehicular Pursuit Summary Reports for years 2014 to 2017.
 4. I would like all of your agency's Use of Force Reports from January 1, 2014 to present date.
 5. I would like all of your agency's Use of Deadly Force Attorney General Deadly Notification Reports for years 2014 to 2017.
 6. I seek the annual basic police academy training, annual firearms requalification training, use of force training, vehicular pursuit training, domestic violence training, cultural diversity training, bias intimidation crimes training, Breathalyzer training, 911 dispatcher and call-taker training, K-9 training recertification certificates for all of the Annual Summary Reports and recertification certificates for all law enforcement officials and officers in your agency for the year 2017.
1. The records are enclosed for 2014-2016. 2017 has not been completed yet.
 2. The Attorney General's Internal Affairs Policy requires a "brief synopsis of all complaints where a fine or suspension of ten days or more was assessed to an agency member." No member of this agency has been assessed a fine or suspension of ten days or more for the years 2014-2017.
 3. The records are enclosed for 2014-2016. 2017 has not been completed yet.
 4. If a member of this agency completes a Use of Force Report, it is part of an investigation and/or arrest. Therefore, that Report would be placed in a prosecution and/or investigative file. There is no way to search through the thousands of files for the years 2014-2017 to find

a Use of Force Report filed by a law enforcement officer in this agency. Records custodians are required to search their files for responsive records, but not to conduct any research on behalf of the requestor. See Donato v. Tp of Union, GRC Complaint No. 2005-182, Analysis (February 28, 2007). OPRA does not force government officials to identify and siphon useful information on behalf of the requestor, nor does it compel them to review, analyze, collate and/or compile data or statistics. N.J. Builders Assoc. v. N.J. Council on Affordable Housing, 390 N.J. Super. 166, 177 (App. Div. 2007), certif. denied, 190 N.J. 394 (2007); MAG Entertainment, LLC v. Division of Alcoholic Beverage Control, 375 N.J. Super. 534 (App. Div. 2005). Thus, your request cannot be fulfilled.

5. The records are enclosed for 2014-2016. There are no records for 2017.

6. Training records:

N.J.S.A. 47:1A-10 exempts personnel records from production in response to an OPRA request. Both the Government Records Council and courts have determined that the "personnel records" exception is not limited to the items included in a personnel file, but rather favors protecting employee confidentiality and private personnel information regarding a particular employee. McGee v. Township of East Amwell, 416 N.J. Super. 602, 614-16 (App. Div. 2010). However, OPRA does not exempt all personnel records from disclosure. North Jersey Media Group, Inc. v. Bergen County Prosecutor's Office, 405 N.J. Super. 386, 389-90 (App. Div. 2009). N.J.S.A. 47:1A-10 additionally identifies specific records and information that remain public.

A public employee's training and education are personnel records, exempt from disclosure unless they fall within one of the statutory exemptions. Kovalcik v. Somerset County Prosecutor's Office, 206 N.J. 581, 593-594 (2011). N.J.S.A. 47:1A-10 provides that "data contained in information which disclose conformity with specific experiential, educational or medical qualifications required for government employment or for receipt of a public pension, but not including any detailed medical or psychological information, shall be a government record." See also Executive Order 11 (Bryne 1974). However, this exemption is further narrowed by Executive Order 26 § 4(c) (McGreevey 2002), which exempts from production "[t]est questions, scoring keys and other examination data pertaining to the administration of an examination for public employment or licensing."

As a result, public employee training and education documents are only subject to production to the extent that they disclose the public employee has completed specific training or education that is **required** for his or her employment. Id. at 593-594. The applicability of this exemption depends on the nature of the contents of the particular documents and the specific educational requirements for employment. Id. at 595. See, e.g., Killino v. Municipal Clerk, Delran Township, GRC Complaint No. 2003-20 (February 18, 2004) (township produced certain firearms and vehicular training records under N.J.S.A. 47:1A-10 because they reflected compliance with "experiential" qualifications for employment of the individuals in question).

Here, training records for each detective who works for this agency are considered personnel records. Kovalcik, supra, at 593-594. Therefore, they are exempt from disclosure

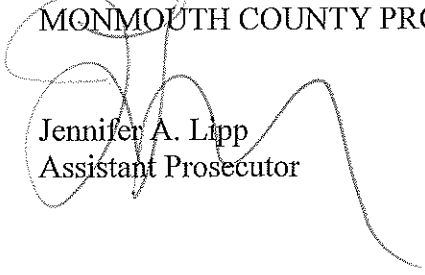
pursuant to OPRA unless one of the statutory exceptions applies. The third exception, data contained in information which discloses conformity with specific experiential, educational, or medical qualifications required for the job of detective, would apply here. N.J.S.A. 47:1A-10; North Jersey Media Group, Inc. v. State, Dept. of Personnel, 389 N.J. Super. 527, 537 (Law Div. 2006). The Attorney General's Office mandates certain in-service training for all law enforcement officers in the State. That training includes firearms requalification, use of force, vehicular pursuit, and domestic violence. In addition, the Attorney General's Directive 2016-5 requires additional training hours through the CLEAR Institute in areas such as de-escalation techniques; cultural diversity and cultural awareness, racial profiling/racially-influenced policing; and, so on.

- a. It is unclear what you mean by "annual basic police academy training." Police officers must attend and graduate from a police academy in order to become a police officer. Further, they may attend continuing education classes at a police academy during their career but those classes are not required. Police officers do not attend basic police academy training classes on an annual basis. What records regarding "annual basic police academy training" are you requesting? Please clarify.
- b. The 2017 records for firearms training are enclosed.
- c. The 2017 records for use of force training are enclosed.
- d. The 2017 records for vehicular pursuit training are enclosed.
- e. The 2017 records for domestic violence training are enclosed.
- f. There are no records for cultural diversity training. No such class has been offered by the CLEAR Institute at this time.
- g. There are no records for bias intimidation crime training. No such class has been offered by the CLEAR Institute at this time.
- h. Detectives in this office are not required to complete training in the breathalyzer, 911 dispatch and call taking, or K-9. Therefore, there are no records pertaining to those kinds of trainings.

In the event of a clarification or appeal, this office reserves the right to raise any other ground for denial not raised in this response. The failure of this office to assert an exception or privilege at this time does not act as a waiver of any grounds for denial.

Police and suspect engaged in a physical confrontation as suspect resisted arrest and assaulted officers with knife. All verbal attempts to get the suspect to submit were unsuccessful. Attempts to physically disarm him were also unsuccessful. In addition, OC spray was deployed but did not deter the suspect. The suspect also attempted to grab Ofr. Washington's holstered weapon. Ofr. Christie was slashed by suspect in right forearm. Suspect also stabbed Ofr. Christie in abdomen, the knife pierced his bullet proof vest but not his skin. Ofr. Christie told Ofr. Washington to shoot suspect. Ofr. Washington shot the suspect once in abdomen and the suspect fell to the ground. The knife was still in the suspect's hand after the shooting. The suspect and officers were all transported to Jersey Shore Medical Center. The suspect was operated on. The bullet is currently lodged in his spine

Brief Summary of Incident:

Officer McGhee conducted a pat down of Dante Allen after making observations of him and speaking to him. The officer felt a bulge consistent with a weapon. At that point, Allen ran away. Officer McGhee pursued him. During the chase, Allen fired his gun at Officer McGhee. Officer McGhee returned fire. He shot Allen in the leg, at which time Allen fell to the ground and dropped the gun. He placed Allen under arrest and the gun was retrieved. A short time later, residents in a house close to the incident reported that 8 year old Cassie Jones had suffered a graze wound to her forehead. It is unclear at this time whose bullet may have struck her.

Brief Summary of Incident:

On Wednesday, December 20, 2016 at approximately 1843 hrs., the Eatontown Police Department responded to the Alltown Pharmacy located at 158 Wyckoff Road for a report of an armed robbery in progress. Interior video surveillance depicts a loan actor dressed in a tan colored hooded jacket, dark pants, dark gloves, tan work style boots and a dark colored scarf around his face. Almost immediately upon the suspect's entrance, one of the female employees retreated to a rear bathroom and dialed 911. The suspect brandished a black semi-automatic handgun and demanded OxyContin. Shortly thereafter, patrol vehicles began arriving in the area and setting up a perimeter. The suspect fled on foot out of the rear door of the pharmacy. Officers in the rear of the pharmacy pursued the subject on foot. The subject climbed over a fence and continued to run down the parking lot area. During the foot pursuit, the suspect reportedly fired shots at the officers pursuing on foot. The officers sought cover before one officer returned fire. No officers were struck by gunfire. The suspect entered a vehicle that was reportedly struck by gunfire causing some of the vehicle's windows to shatter. The vehicle was last seen heading westbound on Route 36. We were notified by the NYPD of three individuals in the Polo Grounds section of the city who hailed an ambulance at 1 a.m. following the shooting. All subjects were from Tinton Falls and Red Bank and one of them, Aaron Riley, had a gun shot wound in the leg needing medical assistance. Riley alleged that he was shot in NY, but the information from Spot Shotter and ALPR data shows subjects traveling from NJ into NYC and the preliminary evidence suggests these subjects may have been involved in the Alltown Pharmacy incident. It is unclear at this early stage of the investigation if the bullet in Riley's leg could have come from Officer Licknack's weapon from the Allentown Pharmacy armed robbery. Doctor suggests Riley's wound may be self-inflicted. Subjects all claim to be high on pills. MCPO Detectives remain on scene at Allentown Pharmacy and in New York responding to Harlem Hospital to meet with NYPD detectives.
