On Monday November 29th 2016 at approximately 2240 hours I was dispatched to 1925 Pacific Avenue (ACMC) Hospital in the PIP room #09 in reference to watching a prisoner. Upon arrival at the above mentioned address this writer was assigned to guard a hospital prisoner (later identified as Norman A. McDougal).

At approximately 0005 hours this writer removed the hand cuffs from the above mentioned prisoner so that the prisoner could utilize the restroom. After the prisoner finished utilizing the restroom, this writer escorted the prisoner back into PIP room #09 to be handcuffed to the hospital bed.

While this writer was cuffing the prisoner to the hospital bed the prisoner attempted to flee the room, this writer immediately grabbed the prisoner pushing him against the wall to contain him inside the room, after a short struggle, this writer and a Security employee was able to take the prisoner to the ground where he was handcuffed (adjusted and double locked).

This writer and several Hospital Security employees were able to place the prisoner onto the hospital bed without further incident. This writer notified Communications via TAC Channel (1) to advise them that the prisoner attempted to flee while in custody. It should be noted that Sergeant M. Camp was advised and later arrived on scene.

At this time no injuries were sustained and the prisoner was checked by the medical unit inside of the PIP on scene without further incident. It should be noted that my AXON body camera was activated during this incident. This writer also completed an AIM incident in reference to this incident.
