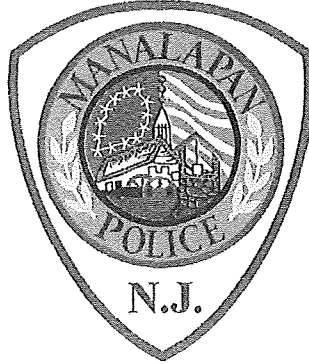

In 2015 there were fifteen internal affairs complaints and/or Investigations conducted within the police department.

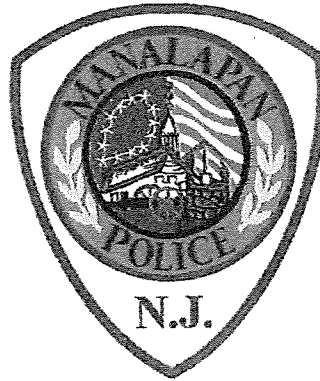
Of the fifteen complaints filed after full and complete investigation eleven were closed with a finding of Exonerated, Unfounded, or Not Sustained.
