To Whom It May Concern:

This office received your records request on December 7, 2017, via email. The records custodian received it the same day. As such, the seven (7) business day deadline to respond to your request is December 18, 2017.

The following records are being requested.

1. "I seek your police department's Internal Affairs Annual Summary Reports for years 2014 to 2017"
2. "I seek a copy of the police department's Public Synopsis of Disciplinary Action for years 2014 to 2017. This report is required pursuant to Requirement 10 of the Attorney General's Internal Affairs Police"
3. "I seek a copy of your police department's Vehicular Pursuit Summary Reports for 2014 to 2017"
4. "I would like all of your police department's Use of Force reports for June 1, 2014 to present day."
5. "I would like all your police department's Police Use of Deadly Force Attorney General Deadly Notification Reports for years 2014 to 2017"
6. "I seek the annual basic police training, annual firearms requalification training, use of force training, vehicular pursuit training, domestic violence training, cultural diversity training, bias intimidation training, Breathalyzer training, 911 dispatcher and call taker training, K-9 training certificates for all the police officers in your department for the year 2017."

1. All records attached are for 2014-2016. 2017 has not been completed yet.
2. The Attorney General's Internal Affairs Policy requires a brief "synopsis of all complaints where a fine or suspension of ten days or more was assessed to an agency member." No member of this department has been assessed a fine or had a suspension of ten days or more for the years 2014-2016.
3. This department did not have any incidents that involved the use of deadly force between 2014 to 2017.
4. Training Records for 2017 are not completed yet.

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you have a right to challenge the decision by the Colts Neck Police to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
