Time to Change-Jersey Style,

The Township of Wall Police Department's ("Police Department") Records Custodian received your Open Public Records Act ("OPRA") request dated November 18, 2017 on November 20, 2017. As such, the seven (7) business day deadline to respond to your request is December 1, 2017. The Police Department is timely providing you with a response to your request in accordance with New Jersey Law.

For ease of reference, your itemized requests are listed below. The Police Department's response immediately follows each item.

1. [The] police department's Internal Affairs Annual Summary Reports for years 2014-2017.

Response: Enclosed please find all readily identified as responsive to this request, Bates Stamped as 0155-0172.

2. [A] copy of the police department's Public Synopsis of Disciplinary Actions for years 2014-2017. This report is required pursuant to requirement 10 of the Attorney General's Internal Affairs Police.

Response: All records readily identified as responsive to this request are encompassed within the Police Department's response to Item No. 1 of your request, Bates Stamped as 0155-0172.

3. A copy of the police department's Vehicular Pursuit Summary reports for years 2014-2017.

Response: Enclosed please find all readily identified as responsive to this request, Bates Stamped as 0173-0175

4. [A]ll of your police department's Use of Force Reports from January 1, 2014 to present date.

Response: Enclosed please find all readily identified as responsive to this request, Bates Stamped as 0001-0154.

Please note that the enclosed records have been redacted in accordance with New Jersey law to protect citizen's personal information in which the individual has a reasonable expectation of privacy. Redactions have been made to remove the following:

- (1) the name of juveniles [Bates Stamped 0137-0138, 0147-0151];
- (2) suspects identified but not arrested [Bates Stamped 0033-0034, 0049, 0098-0100, 0117, 0120-0121, 0130-0131, 0137-0138, 0146-0149];
- (3) information relating to a person's medical, psychiatric, or psychological history, treatment, or evaluation. [Bates Stamped 0025, 0033, 0052-0054, 0061-0062, 0075-0078, 0086-0095, 0098-0100, 0102-0105, 0116-0117, 0130-0131, 0147-0149], 0147-

(4) Confidential identifiers related to a domestic violence incident [Bates Stamped 0006-0008, 0031-0032, 0044-0046, 0063-0066, 0106, 0109]

N.J.S.A. 47:1A-1 provides that “a public agency has a responsibility and an obligation to safeguard from public access a citizen’s personal information with which it has been entrusted when disclosure thereof would violate the citizen’s reasonable expectation of privacy.” N.J.S.A. 47:1A-9.b allows exemptions from disclosure any grant of confidentiality established or recognized by the Constitution of this State, statute, court rule or judicial case law, to apply to OPRA.

With respect to the identification of juvenile offenders, New Jersey courts have held that such information is confidential. See North Jersey Media Group Inc. v. Township of Teaneck, No. BER-L-6375-14, 2014 WL 6634358 at *7-8 (Law Div. 2014). Additionally, Executive Order No. 26 (McGreevy 2002) exempts from disclosure “information relating to medical, psychiatric or psychological history, diagnosis treatment or evaluation.” See also Rivera v. Town of West New York, GRC Complaint No. 2010-208 (Feb. 2013) (upholding exemption of medical information under Executive Order No. 26). The Government Records Council has also held that use of force reports must be provided in redacted form, except for the names of subjects not arrested. See Rivera v. City of Bayonne, GRC Complaint No. 2012-87 (Aug. 2012).

Lastly, the name of a victim of domestic violence must be redacted. Although there is a provision exempting victim’s records under OPRA, the records must be maintained by a “victim’s rights agency.” N.J.S.A. 47:1A-1.1. A police department is not a victim’s right agency and therefore this exemption does not apply. See North Jersey Media Group v. Borough of Paramus, 2011 WL 9287204 (Law Div. 2015). Nevertheless, victim’s records may be withheld under OPRA’s privacy provision. See North Jersey Media Group v. Borough of Paramus, 2011 WL 9287204 (Law Div. 2015); N.J.S.A. 47:1A-1 (“[A] public agency has a responsibility and an obligation to safeguard from public access a citizen’s personal information with which it has been entrusted when disclosure thereof would violate the citizen’s reasonable expectation of privacy.”). Additionally, the records of domestic violence victims may be exempt from disclosure under the confidentiality provisions of the Prevention of Domestic Violence Act of 1991. N.J.S.A. 2C:25-33. In Butala v. Township of Aberdeen, GRC Complaint No. 2014-194 (Feb. 26, 2015), the GRC ruled that the Custodian lawfully denied access to responsive domestic violence records because same are exempt under the Prevention of Domestic Violence Act of 1991, and no exceptions in the statute provide for exceptions to access for victims. Id. (citing N.J.S.A. 47:1A-6; N.J.S.A. 47:1A-9(a); N.J.S.A. 2C:25-33; VanBree v. Bridgewater Twp. Police Dep’t (Somerset), GRC Complaint No. 2014-122 (October 2014)). In VanBree, the GRC was tasked with determining whether the custodian lawfully denied access to certain records under the PDVA. In concluding that the custodian lawfully denied access to same, the Council confirmed that the records definitively related to a domestic violence incident and noted that the PDVA included a confidentiality clause. Id. The GRC, in Butala, found that it was satisfied that the records at issue in the proceeding “related to a domestic violence incident.” GRC Complaint No. 2014-194. In reaching its decision the GRC observed that “[t]he [PDVA] offers a multitude of protections to victims.” Id.
