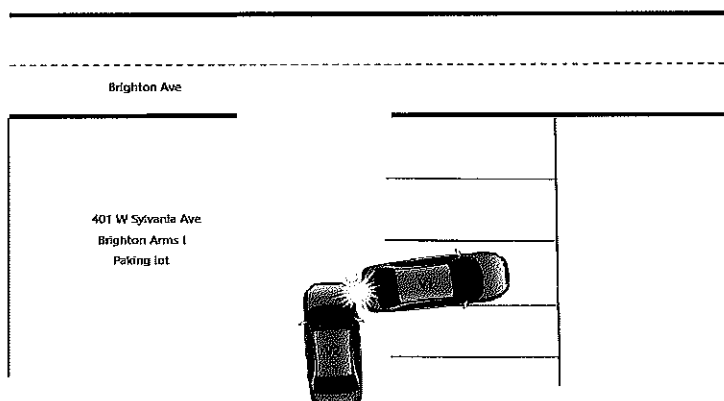

145 Crash Description/Narrative

Vehicle 1 was backing out of a parking space, traveling south while Vehicle 2 was traveling west through the parking lot of Brighton Arms I (401 W Sylvania Ave). Vehicle 1 backed out of the parking space in an unsafe manner and did not yield to Vehicle 2. Subsequently, Vehicle 1 backed into the front passenger side of Vehicle 2. As a result of the collision Vehicle 1 sustained minor damage to the rear end and Vehicle 2 sustained disabling damage with the primary damage sustained to the front passenger side. Driver 2 complained of back pain as a result of the collision and refused medical assistance. Vehicle 2 was parked in a nearby parking space by the owner.
