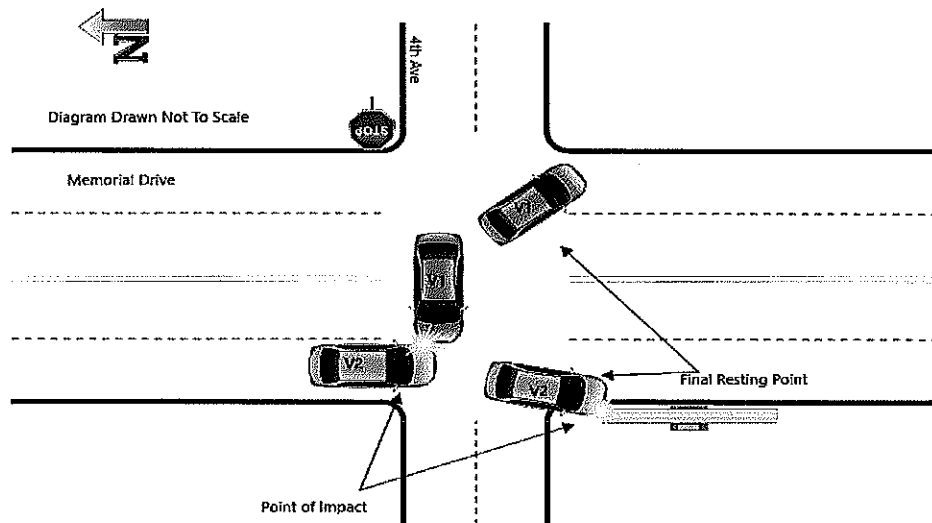

145 Crash Description/Narrative

Vehicle 2 was traveling South on Memorial Dr in the right lane. Vehicle 1 was traveling West on 4th Ave and came to a stop at the stop sign located at 4th Ave and Memorial Dr. Vehicle 1 proceeded to cross over Memorial Dr and Vehicle 1's front passenger side bumper struck Vehicle 2's driver-side bumper. Vehicle 1 proceeded to spin counter-clockwise and came to a stop on Memorial Dr in the north-bound lane, facing East. Vehicle 2 proceeded to travel South, and struck the guard rail located on the west-side of Memorial Dr, and came to a stop.

Vehicle 1 sustained disabling damage to the front end. Vehicle 2 sustained disabling damage to the front end. As a result of the accident, the guard-rail (5-40a 2) was damaged and DOT was notified. There were no reported injuries.

NCOEM responded for fluid and debris clean-up. Jim's Towing responded and towed both vehicle's which were towed to Impact Autobody. Vehicle 1's registration was suspended and will be held until proof of valid insurance and registration are provided.
