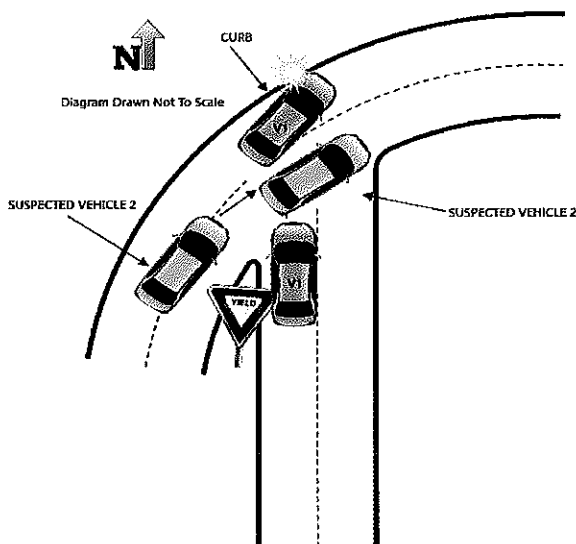

145 Crash Description/Narrative

BOX 118A - Driver 1 stated after yielding she proceeded onto the ramp into Avon. A vehicle passed them on their right side which caused them to collide with the curb. Driver 1 stated there was no collision with the suspected vehicle.

Vehicle 1 was traveling north negotiating the State Route 35 interchange into Avon. Vehicle 1 stopped and yielded to oncoming traffic. Vehicle 1 then proceeded onto the ramp into Avon. At this time a vehicle passed them on their right side. Due to this the Driver of vehicle 1 swerve left and the driver side front tire struck the northern curb line. Driver 1 stated there was no collision between the two vehicles and she was unable to provide any vehicle information for the alleged vehicle that passed her.

Vehicle 1 sustained disabling damaged to the driver's side, front bumper and tire. The vehicle was towed from the scene by Bennett's towing.

Both Driver and Passenger complained of head pain from the collision. Both were transported to JSUMC by Neptune City First Aid Squad.
