NARRATIVE:

V1 WAS PARKED ALONG OCEAN AVENUE. V2 WAS PARKED DIRECTLY TO THE LEFT OF V1. AS V2 BEGAN TO REVERSE OUT OF THE SPOT, THEY STRUCK THE DRIVER SIDE REAR OF V1. MINOR DAMAGE SUSTAINED TO THE 7'O'CLOCK POSITION OF V1 AND THE 5'O'CLOCK POSITION OF V2.

CONTRIBUTING CIRCUMSTANCES OF V2:

THE OPERATOR OF V2 STATED THEY MISJUDGED THE ANGLE OF THE WHEEL AS THEY REVERSED OUT OF THE SPOT RESULTING IN THEM STRICKING THE DRIVER SIDE REAR OF V1.

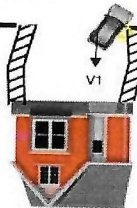
144 Crash Diagram (NOT TO SCALE)

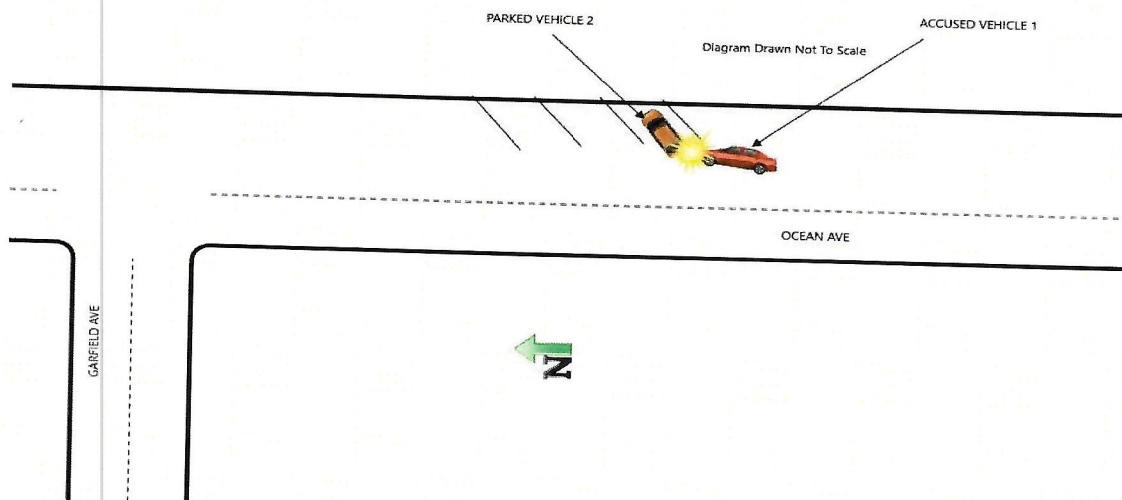

145 Crash Description/Narrative

Apparent Contributing Circumstances 1 (Vehicle 01)- DRIVER ONE EXPLAINED TO PATROL THAT HE WAS LOOKING AT HIS FRONT RIGHT BUMPER AND WHILE DOING SO TOOK HIS EYES OFF THE ROAD CAUSING HIS FAILURE TO MAINTAIN LANE.

Sequence Of Events 1 (Vehicle 01)- DRIVER ONE EXPLAINED TO PATROL THAT HE TOOK HIS EYES OFF THE ROAD CAUSING HIM TO MOVE TO THE RIGHT STRIKING PARKED VEHICLE 2.

WHILE ON PATROL I WAS FLAGGED DOWN BY AN UNKNOWN SUBJECT WHO STATED THEY JUST WITNESSED A HIT AND RUN ON OCEAN AVE IN THE PAST 10 SECONDS. I WITNESSED HEAVY DAMAGE TO A PARKED VEHICLE THAT THE WITNESS POINTED OUT.

A BOLO WAS PUT OUT TO PATROLS AND SURROUNDING TOWNS FOR A VEHICLE WITH HEAVY FRONT END DAMAGE. I WAS ABLE TO LOCATE THE VEHICLE IN QUESTION ON THE OTHER SIDE OF TOWN. THE DRIVER OF THE VEHICLE WHO HAD STEPPED OUT AND WALKED DOWN THE STREET MADE HIS WAY TO ME WHERE HE ADVISED THAT HE WAS THE ONE WHO CAUSED THE ACCIDENT. 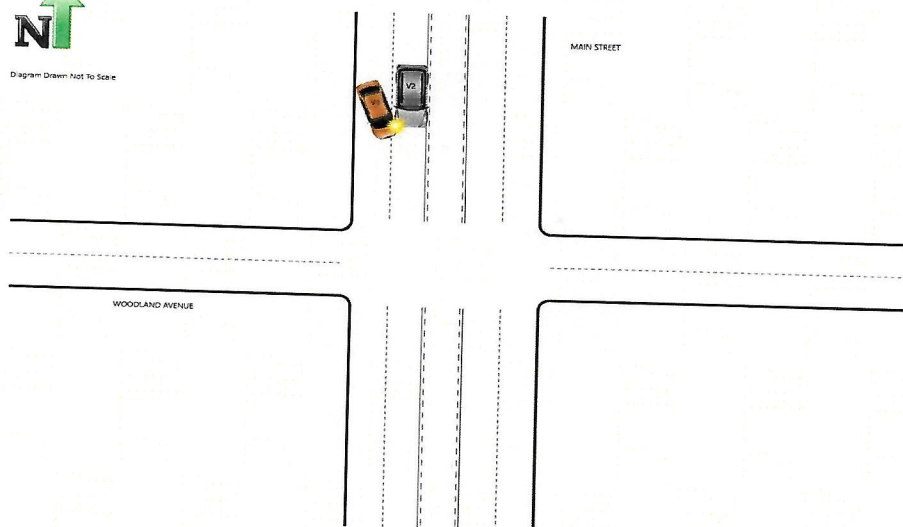

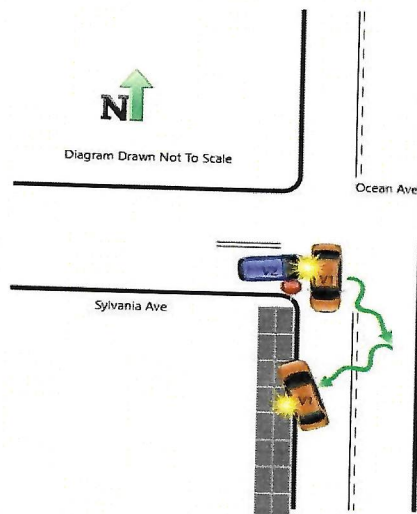

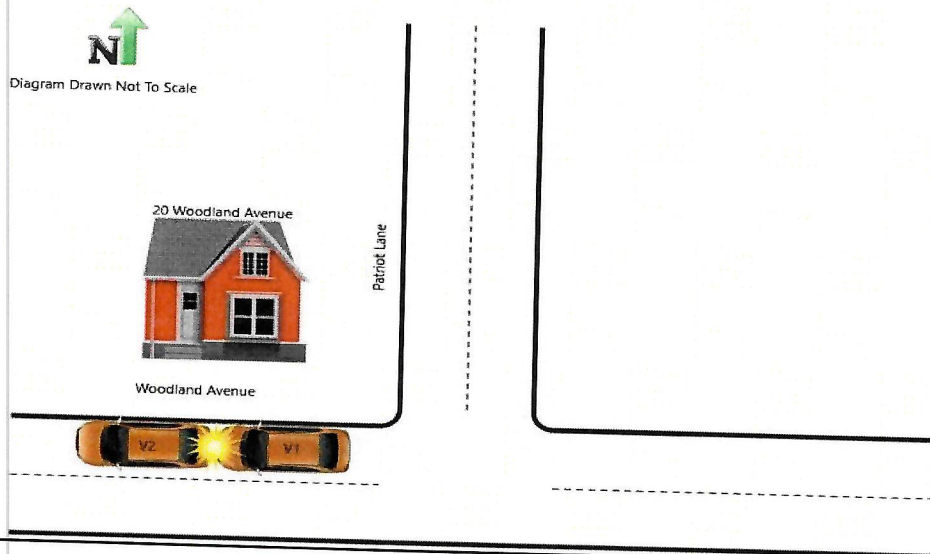

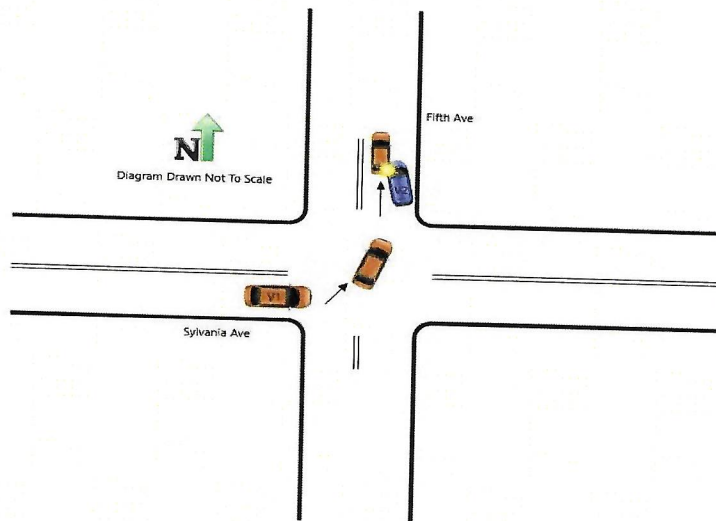

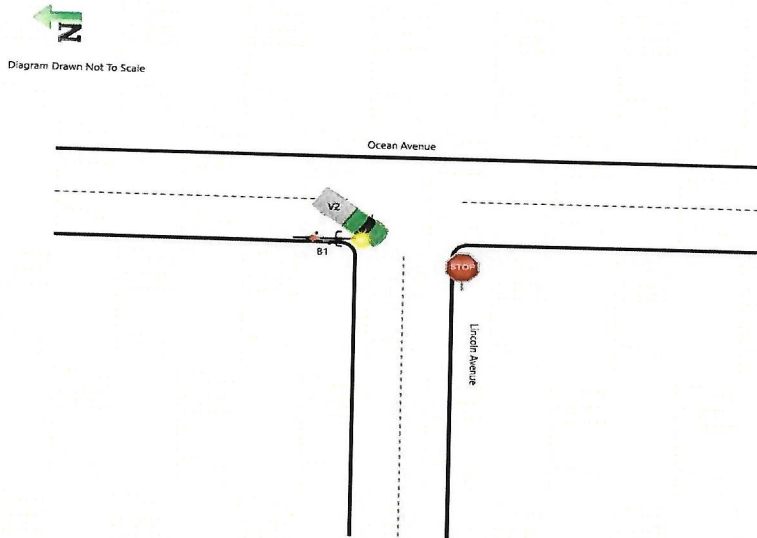

145 Crash Description/Narrative

B1 was travelling south on Ocean Ave, V2 was also traveling south on Ocean Av making a right turn to head west on Lincoln Ave. While making the turn from Ocean Ave onto Lincoln Ave the front of B1 collided with the passenger side of V2. Collision caused minor damage to both involved.

Witness observed V2 traveling south directly in front of his vehicle. He then observed B1 ride past him on the right side, heading south in the southbound lane of Ocean Ave. V2 put his signal to turn and while turning B1 collided into the side of V2.
