145 Crash Description/Narrative

This change report adds new information that V1 had also struck another vehicle, herein referred to as V3. Prior to striking V2, V1 was traveling south in the parking lot, and struck V3, which was legally parked in a parking space, facing east. D1 then put the vehicle in reverse and struck V2, which is described in the initial report. This was also proven by surveillance footage provided by V3; same is attached to the filed of this report.

The front driver fender of V1 struck the rear driver fender of V3. There was moderate/functional damage to both vehicles.
