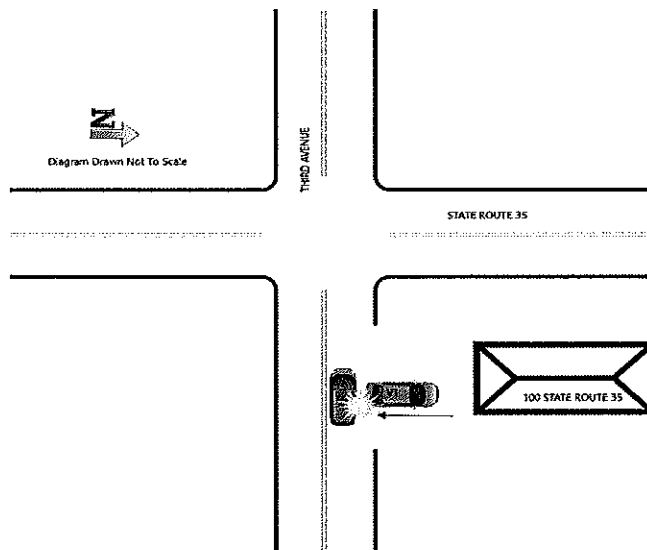

145 Crash Description/Narrative

Vehicle 1 was in the parking lot of 100 State Route 35. Vehicle 2 was in traffic on Third Avenue approximately 50 feet East of State Route 35. Vehicle 1 began to back out of the parking lot and onto Third Avenue. Driver 1 advised they did not see Vehicle 2 behind them. Vehicle 1 then backed into Vehicle 2. As result of the accident, Vehicle 1 sustained moderate damage to the rear passenger side bumper. As a result of the accident, Vehicle 2 sustained moderate damage to the passenger side rear door area.

No tows were needed and no injuries were reported.
