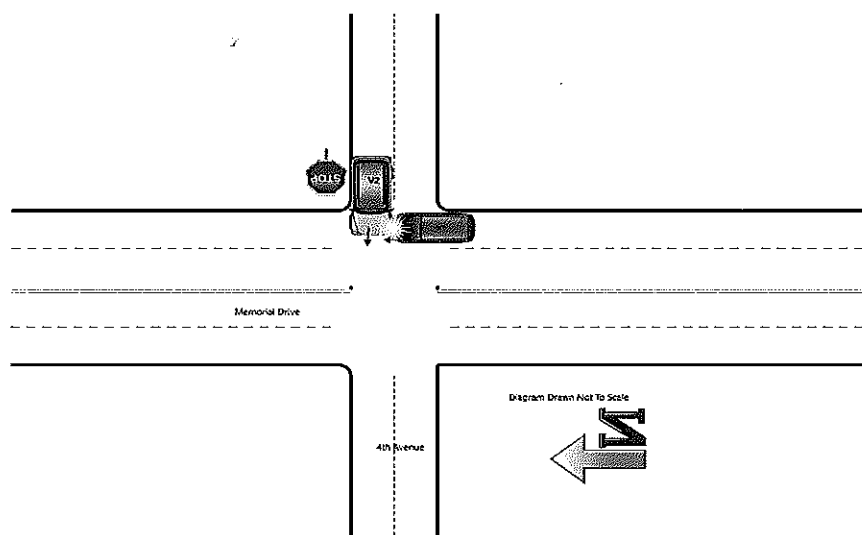

145 Crash Description/Narrative

Vehicle 1 was traveling north on Memorial Drive, south of 4th Avenue. Vehicle 2 was traveling west on 4th Avenue, east of Memorial Drive. Vehicle 2 entered the intersection of Memorial Drive and 4th Avenue, as Vehicle 1 was approaching the intersection. The front bumper of Vehicle 1 collided with the driver side wheel well of Vehicle 2. Both vehicles sustained minor damage.

Both drivers stated they were not injured and did not need medical attention. Both vehicles were able to be driven.

Driver 2 stated she stopped at the stop sign and then entered the intersection. Driver 2 was issued summons # 1335 E24 001288 for failure to stop or yield (39:4-144).
