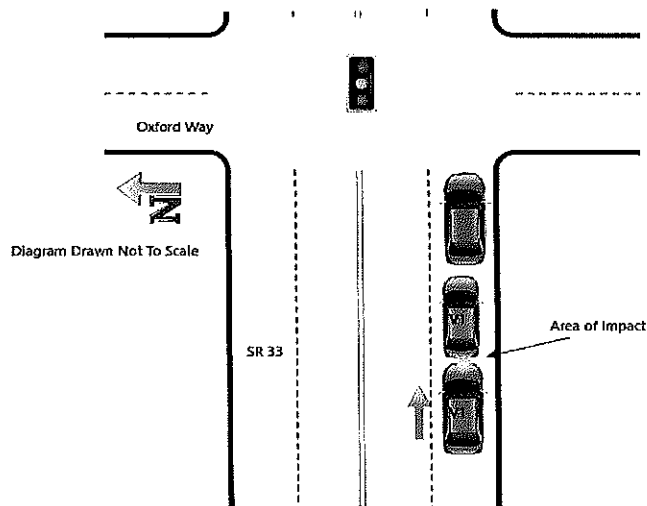

145 Crash Description/Narrative

Vehicle 2 was traveling East on SR 33 in the right lane, and stopped in traffic behind an unknown vehicle. Vehicle 1 was traveling East on SR 33 in the right lane, behind Vehicle 2. Vehicle 1 began to start in traffic before Vehicle 2, and Vehicle 1's front bumper struck Vehicle 2's rear bumper.

Vehicle 1 sustained damage to the front bumper. Vehicle 2 sustained damage to the rear bumper. Vehicle 2 Passenger 03 complained of neck pain. NTFA responded and Passenger 03 refused medical attention. There were no tows required.
