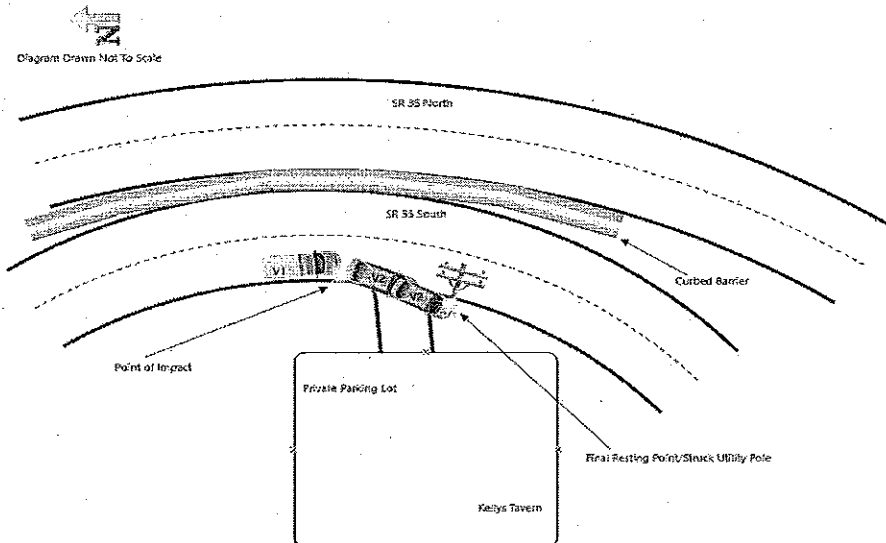

145 Crash Description/Narrative

As per the driver and passenger of Vehicle 2, Vehicle 1 is an unknown older model red pick-up truck with an extended cab and was last seen traveling South on SR 35. Surrounding towns were advised of the incident and Vehicle 1 should have a white paint transfer on the front bumper. Driver 2 was unable to provide a make of the vehicle or a description of the driver.

Vehicle 2 was traveling South on SR 35 in the right lane and turning right into the parking lot of 43 SR 35, Kelly's Tavern. Vehicle 1 was traveling South on SR 35 in the right lane and the front of Vehicle 1 collided with Vehicle 2's rear bumper. Vehicle 2 was pushed forward and Vehicle 2's front bumper collided with utility pole JC655NC. Vehicle 1 fled the scene traveling South on SR 35.

The damage to Vehicle 1 is unknown at this time. Vehicle 2 sustained damage to the front and rear bumper. There were no reported injuries at this time. There was no visible damage to the utility pole.

I responded to Kelly's Tavern and spoke with staff and was able to view black and white video footage of the incident. From the video surveillance, I was unable to determine the make/model of the vehicle or a description of the driver. A copy of the video footage is attached to this report.
