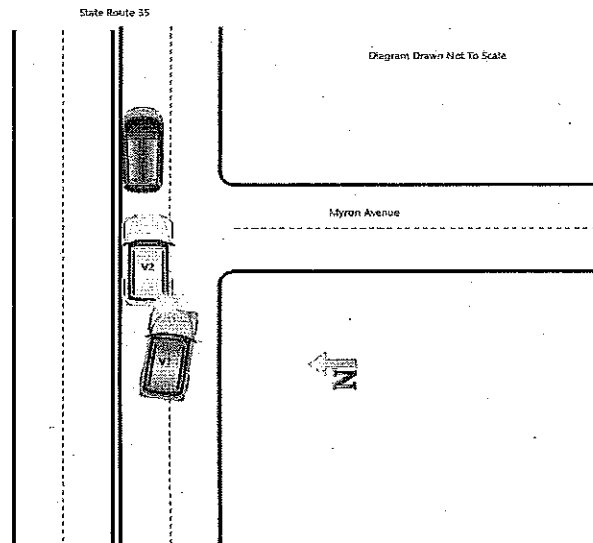

145 Crash Description/Narrative

118a- Driver 1 stated he missed the brake pedal when attempting to stop.

Vehicle 1 was traveling south on State Route 35. Vehicle 2 was traveling south on State Route 35 in front of Vehicle 1. Vehicle 2 stopped in traffic. The driver of vehicle 1 stated he attempted to press the brake with his foot and missed the pedal. Vehicle 1 could not stop on time and the left front of vehicle 1 struck vehicle 2 on its rear bumper. Vehicle 1 sustained moderate damage to its front bumper. Vehicle 2 sustained moderate damage to its rear bumper. Both Vehicles were driven from the scene. No injuries were reported on scene.
