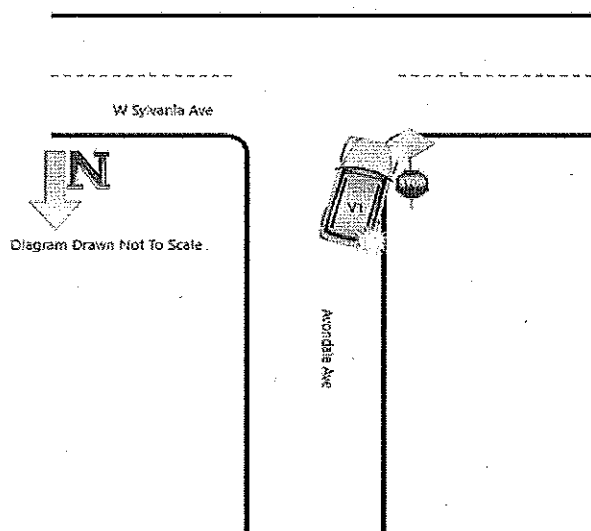

145 Crash Description/Narrative

Box 126B: Vehicle drove off the right side of the roadway.

Vehicle 1 was traveling south on Avondale Avenue before coming to a complete stop at the posted stop sign at the intersection of W Sylvania Avenue. Vehicle 1 then attempted to make a right hand turn onto W Sylvania Avenue. Driver 1 turned too tightly and subsequently struck and mounted the western curb of Avondale Ave and struck the intersection's street sign. The front passenger side of the vehicle struck the sign. The vehicle continued forward into the intersection and then reversed back over the curb and into the stop sign. The rear passenger side of the vehicle struck the stop sign. The vehicle sustained minor damage as a result of striking both fixed signs. There were no fluid leaks to the vehicle or injuries to the driver.

Neptune City DPW responded to the scene and assessed the damage to the street sign. NCPDW was able to temporarily adjust the sign into an upright position. Repairs will be made at a later time. The Monmouth County Highway Department was notified of the damaged Stop sign. It was readjusted into an upright position for the time being.

Driver 1 was found to not have an active drivers license and was unable to locate the vehicle's proof of insurance. Driver 1 was issued traffic citations for driving without a license (1335 089089) driving without vehicle insurance (1335 089090), and careless driving (1335 089091).

The vehicle was impounded from the scene by Bennett's Auto Recovery to Jost Collision.
