

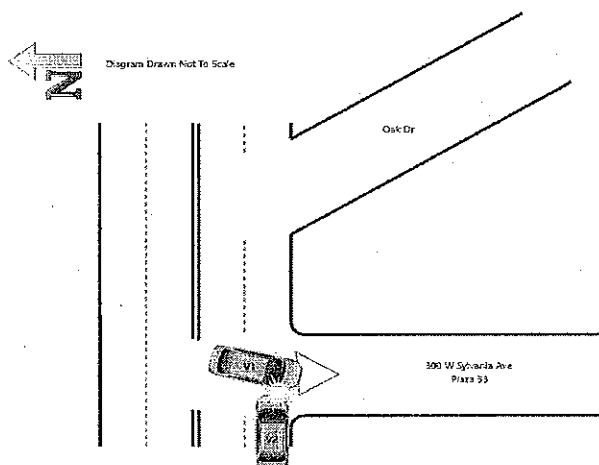

145 Crash Description/Narrative

Vehicle 1 was traveling in the left westbound lane of traffic on State Route 33 (SR 33). Vehicle 1 slowed to prepare for a left turn into Plaza 33 (300 W Sylvania Ave). Vehicle 2 was traveling in the right eastbound lane of SR 33. Vehicle 1 failed to yield to the right of way and turned left towards the Plaza 33 entrance, subsequently traveling directly in front of the path of Vehicle 2, causing a collision. The impact caused Vehicle 2 to be pushed sideways as it continued towards the Plaza 33 entrance, subsequently mounting the curb at the main entrance.

Note: No damage to the curb divider occurred.

The front end of Vehicle 2 collided with the front passenger side of Vehicle 1. Vehicle 2 sustained disabling damage to the front end as a result of the collision and Vehicle 1 sustained disabling damage to the front passenger side as a result of the initial impact before mounting the curb. Both vehicles had fluid leaking into the roadway. Neptune City OEM responded to the scene and cleaned the fluid from the roadway. Both vehicles were disabled and towed from the scene by Atlantic Auto Recovery.

Driver 1 complained of pain in her left hand and Driver 2 complained of back pain. Neptune Twp First Aid responded to the scene. Both drivers refused medical assessments.

A Victim Notification form was completed and submitted to the Neptune City Municipal Court. Driver 1 was issued one traffic citation for Right of Way Entering Private Driveway (39:4-66.1) on citation 1335 088404 and one traffic citation for Expired DL on traffic citation #1335 088405.
