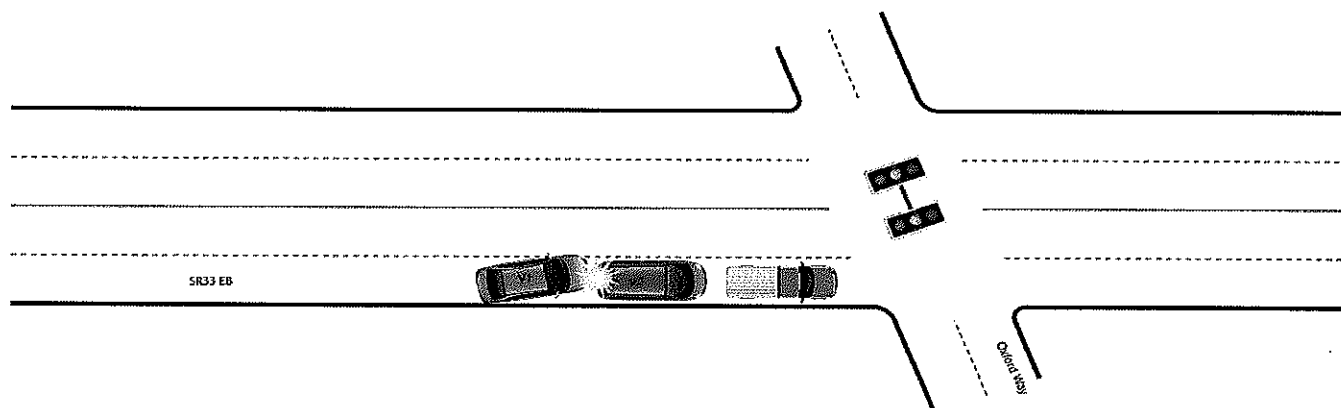

145 Crash Description/Narrative

Box 25: Glacier Insurance Company / NAIC :10480

Vehicle #2 was travelling East on SR 33 in the right lane, slowing down in traffic for a yellow traffic signal. Vehicle #1 was travelling behind Vehicle #2, also East on SR 33 in the right lane. Vehicle #1 observed Vehicle #2 coming to a stop and attempted to pass Vehicle #2, in attempt to avoid collision, by changing lanes. In doing so, the front passenger side bumper/headlight of Vehicle #1 collided with the rear driver side bumper of Vehicle #2. No injuries were reported and both vehicles were driven from location.
