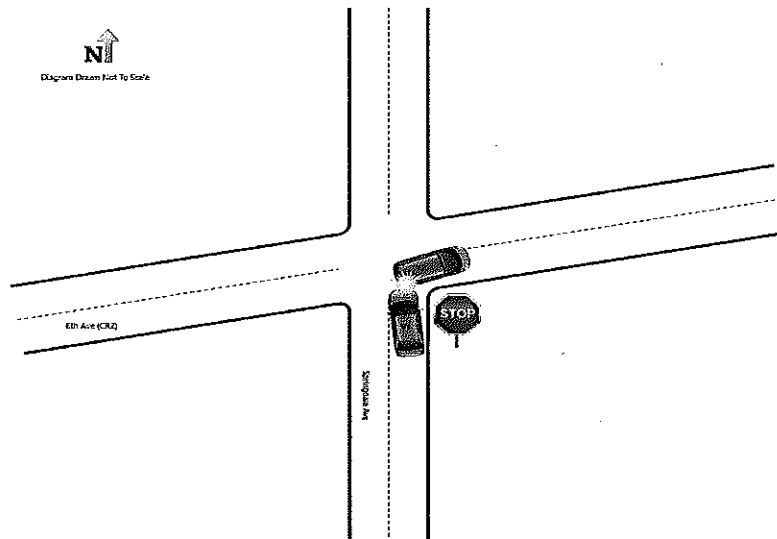

145 Crash Description/Narrative

Vehicle #1 was stopped for a stop sign at Springdale Ave and 6th Ave, heading North on Springdale Ave. Vehicle #1 believed the intersection was clear and proceeded into the intersection but in doing so collided with Vehicle #2, which was heading East on 6th Ave. The front passenger side bumper of Vehicle #1 collided with the rear passenger side quarter panel and tire of Vehicle #2. Vehicle #2 was towed by Bennett's Towing, and Vehicle #1 was driven from the scene. No injuries were reported.
