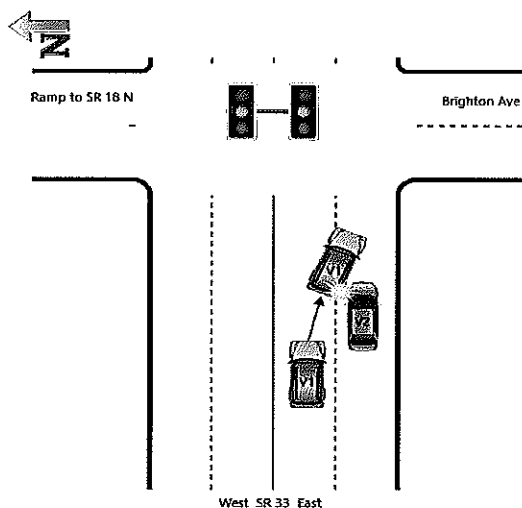

145 Crash Description/Narrative

V1 was traveling east on SR 33 East, in the left hand lane. V2 was traveling east on SR 33 East, in the right hand lane. D1 made an unsafe lane change into the right hand lane, without making sure it was clear first. In doing so, D1 drove into V2. The front passenger fender of V1 struck the rear driver fender of V2.

Both vehicles were able to be driven, and remained legally parked on scene. D2 and the front passenger in V2 both were transported to JSUMC by NTFAS for complaints of pain.

D1 was unlicensed, and patrols remained on scene with him until he was picked up by a licensed driver. D1 was issued summonses for 39:4-88b and 39:3-10.
