145. Crash Description/Narrative

Investigation revealed that Vehicle 2 was on the ramp of US Highway 1 North waiting to merge onto Jersey Ave when Vehicle 1 failed to observe Vehicle 2 at a complete stop and rear ended it.

Driver 2 stated he was at a complete stop and was rear ended by Vehicle 1. Driver 1 stated he failed to stop in time and rear ended Vehicle 2.

Driver 1 sustained face and head injuries and was treated by NBTfARS and transported to St. Peters Hospital for further evaluations. No other injuries were reported at this time by all parties.

Vehicle 1 was at fault for this accident. Vehicle 1 was disabled and towed by Jays Towing. Driver 1 was issued a citation for Careless Driving 39:4-97 E20000119.

Nothing further to report.

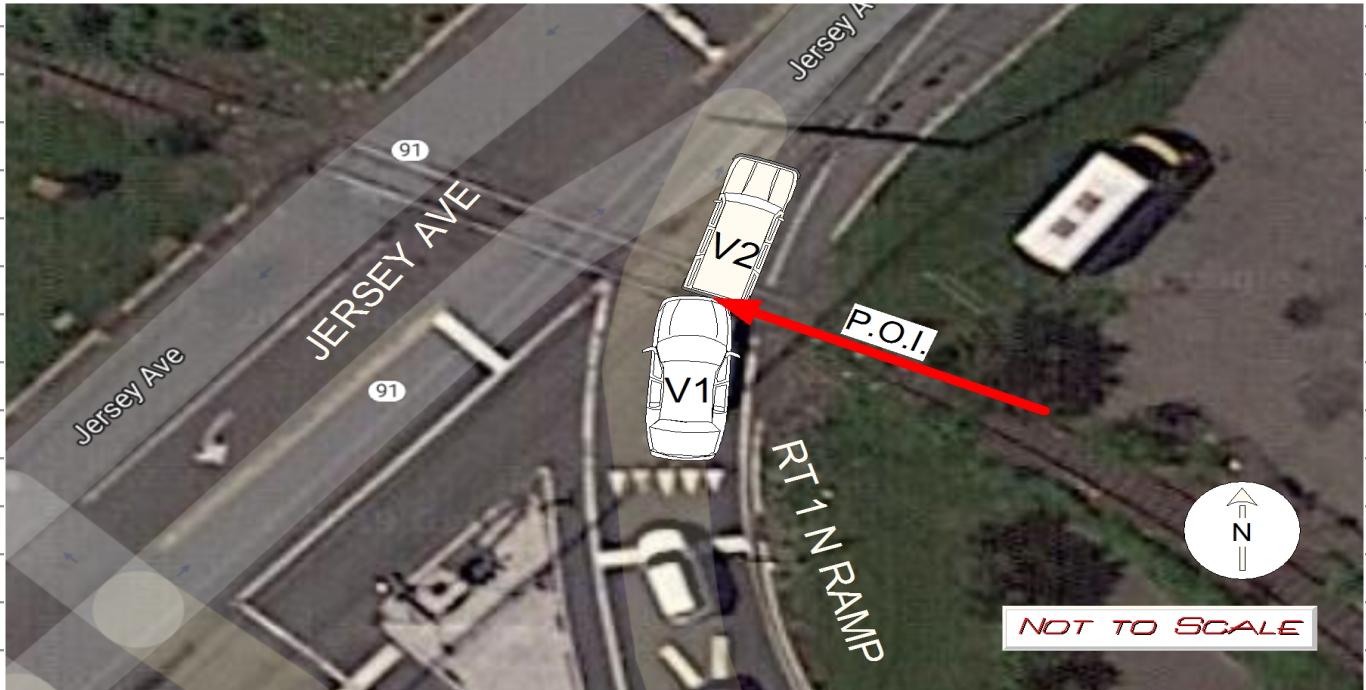
