145. Crash Description/Narrative

Investigation revealed that V1 was driving in circles through the complex parking lot when Driver 1 attempted to back into a parking space. Driver 1 did not see V2 behind him and backed into it. V2 was parked and unoccupied during the crash. Driver 1 then repositioned his vehicle and parked in a neighboring space. Driver 1 then exited his vehicle, did not contact police, and went into his residence. Driver 1 was later arrested for DUI and charged with multiple motor vehicle violations. V1 was found to be at fault for this crash.

Box #24/25 - Driver 1 was unable to provide his insurance information and was mailed the appropriate motor vehicle summons for failing to produce his insurance card, 39:3-29C, and No liability insurance, 39:6B-2.

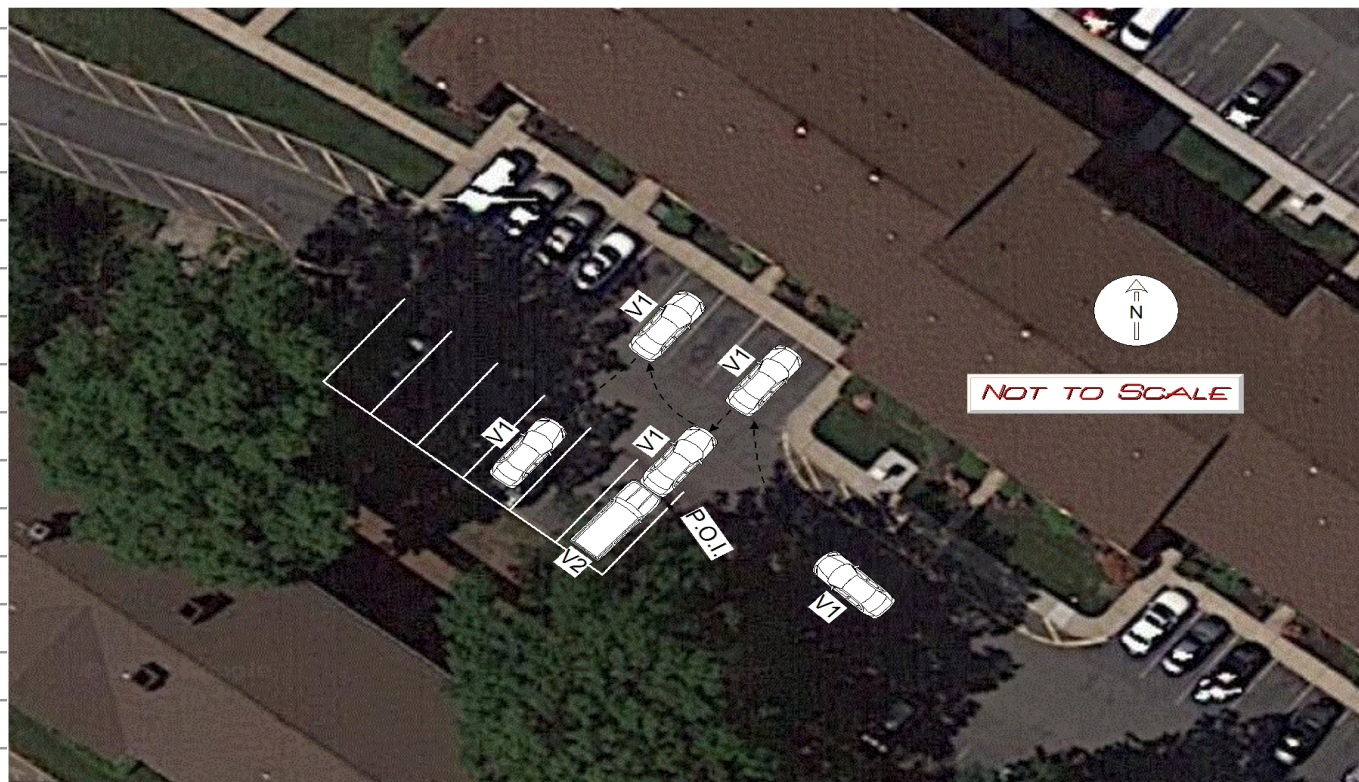
