**145. Crash Description/Narrative**

Investigation revealed that Vehicle 3 was stopping for the amber light at the intersection of Rt 1 South and North Oaks Blvd and came to a complete stop when Vehicle 2 rear ended her. Vehicle 2 came to a complete stop after rear ending Vehicle 3 when Vehicle 1 rear ended her.

Driver 1 stated he failed to stop in time and rear ended Vehicle 2.

Driver 2 stated she failed to stop in time and rear ended Vehicle 3. Driver 2 stated the only damage she observed on her own vehicle was on the rear bumper.

Driver 3 stated she came to a complete stop when she observed the amber traffic light and was rear ended by Vehicle 2. Driver 3 stated no damage was observed on the rear of her vehicle.

Vehicle 1 was at fault for this accident. No injuries were reported at this time. Driver 1 was issued a citation for Careless Driving 39:4-97 (E20000201)

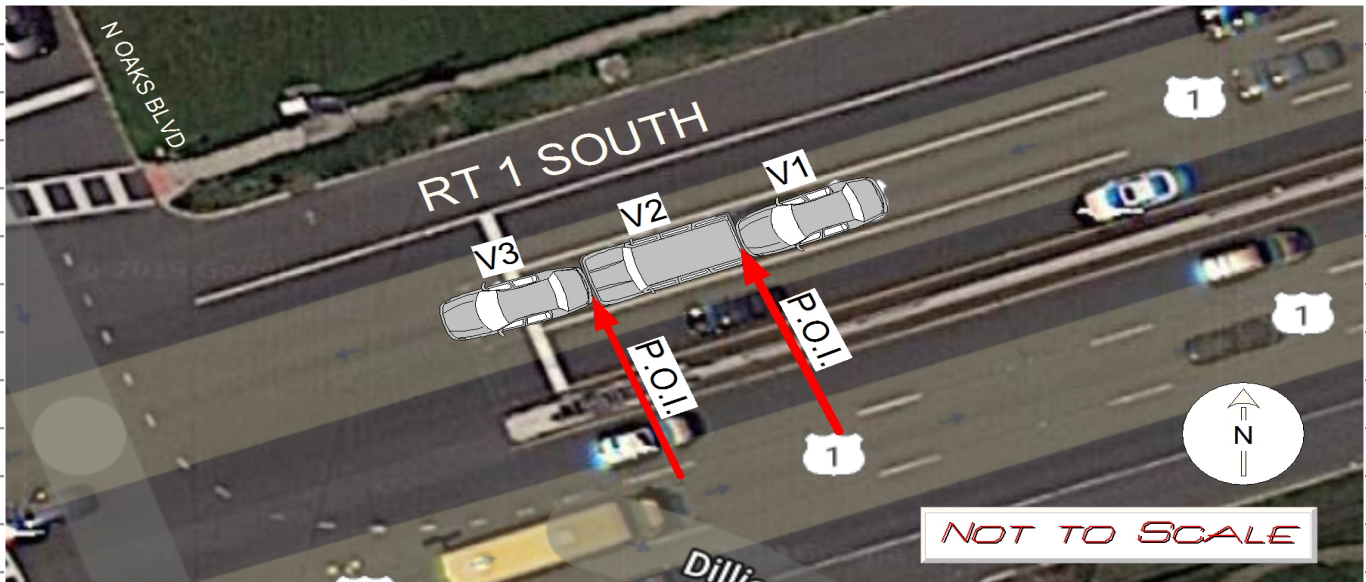
