145. Crash Description/Narrative

Veh 1 made a right turn from North Oaks Blvd onto Livingston Avenue northbound.

Veh 2 was traveling North on Livingston Avenue passing North Oaks Blvd.

Investigation revealed, Veh 2 was traveling north on Livingston Avenue when it stopped to allow a vehicle to exit from 1330 Livingston Avenue. When Veh 2 stopped, Veh 1 made a right hand turn from North Oaks Blvd onto Livingston Avenue and struck V2 from behind.

Driver 1 stated when he turned, Veh 2 stopped short which is when he struck the rear of Veh 2.

Driver 2 stated he stopped to allow a vehicle to exit the parking lot when he was struck from behind by Veh 1.

Veh 1 sustained moderate damage and Veh 2 sustained disabling damage. Veh 2 was towed from the scene by Coppas.

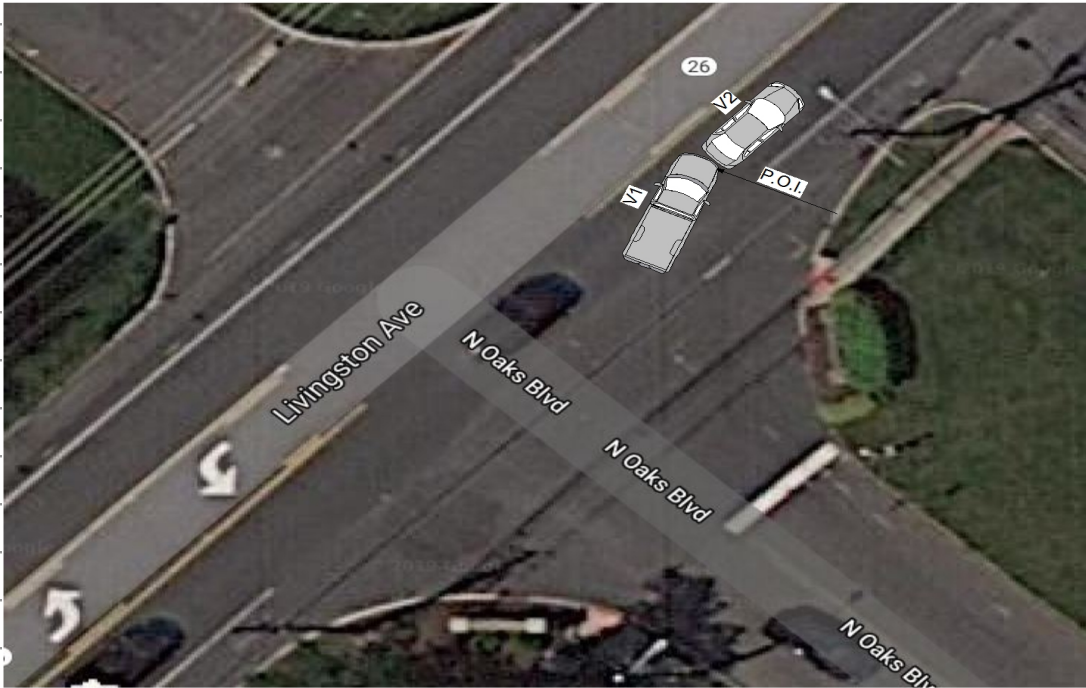
