145. Crash Description/Narrative

V2 was traveling south on George's Road when V1, who was attempting to make a left turn onto George's Road off of Laurel Place, entered the roadway and the crash occurred. Driver 1 stated that she believed traffic stopped for her in order to make the left turn onto George's Road so as she pulled into the intersection she was struck by V2. Driver 2 stated that while traveling straight on George' Road V1 pulled into the roadway in front of her and wasn't able to stop in time, striking V1. Investigation revealed that V1 failed to yield the right of way as it had the greater obligation when entering the roadway with a stop sign, therefore V1 was found to be at fault for this crash.

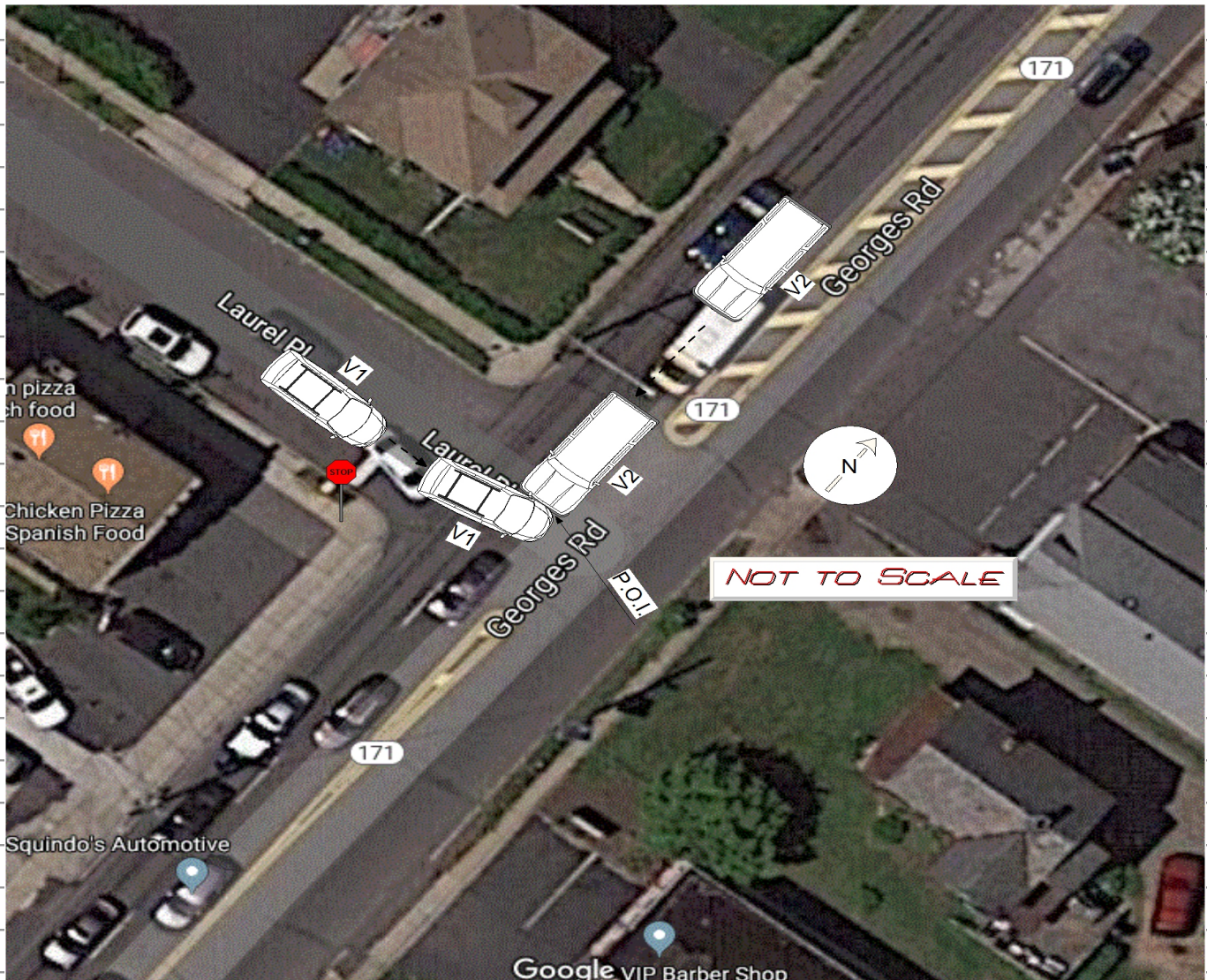
