145. Crash Description/Narrative

Upon responding to 19 Princess Dr. relative to a collision with a parked vehicle, I determined that vehicle number one struck vehicle number 2 that was parked in front of number 19. Based on the damages to both vehicles, it appears that the operator of vehicle number 1 did not have enough stopping distance as the vehicle attempted to stop on a snowy road surface, which resulted in the vehicle sliding on the road surface until it collided into the rear driver's side of the bumper. The operator further added that she was travelling east on Princess Dr. around the turn in the roadway, when she observed a vehicle backing out of the driveway of 19 Princess Dr. As the vehicle proceeded to travel west on Princess Dr. away from number 19, the operator added that she applied her brakes and swerved right to avoid colliding into the vehicle that was allegedly on the wrong side of the roadway. The actions resulted in the collision into the parked vehicle. The residents of number 19 Princess Dr. stated that they observed vehicle number 1 approaching the turn in the roadway at a speed that was not conducive for the road surface condition. As they passed vehicle number 1, vehicle number 1 was allegedly observed sliding into the parked vehicle in front of number 19 Princess Dr. No injuries were reported by the operator of vehicle number 1.

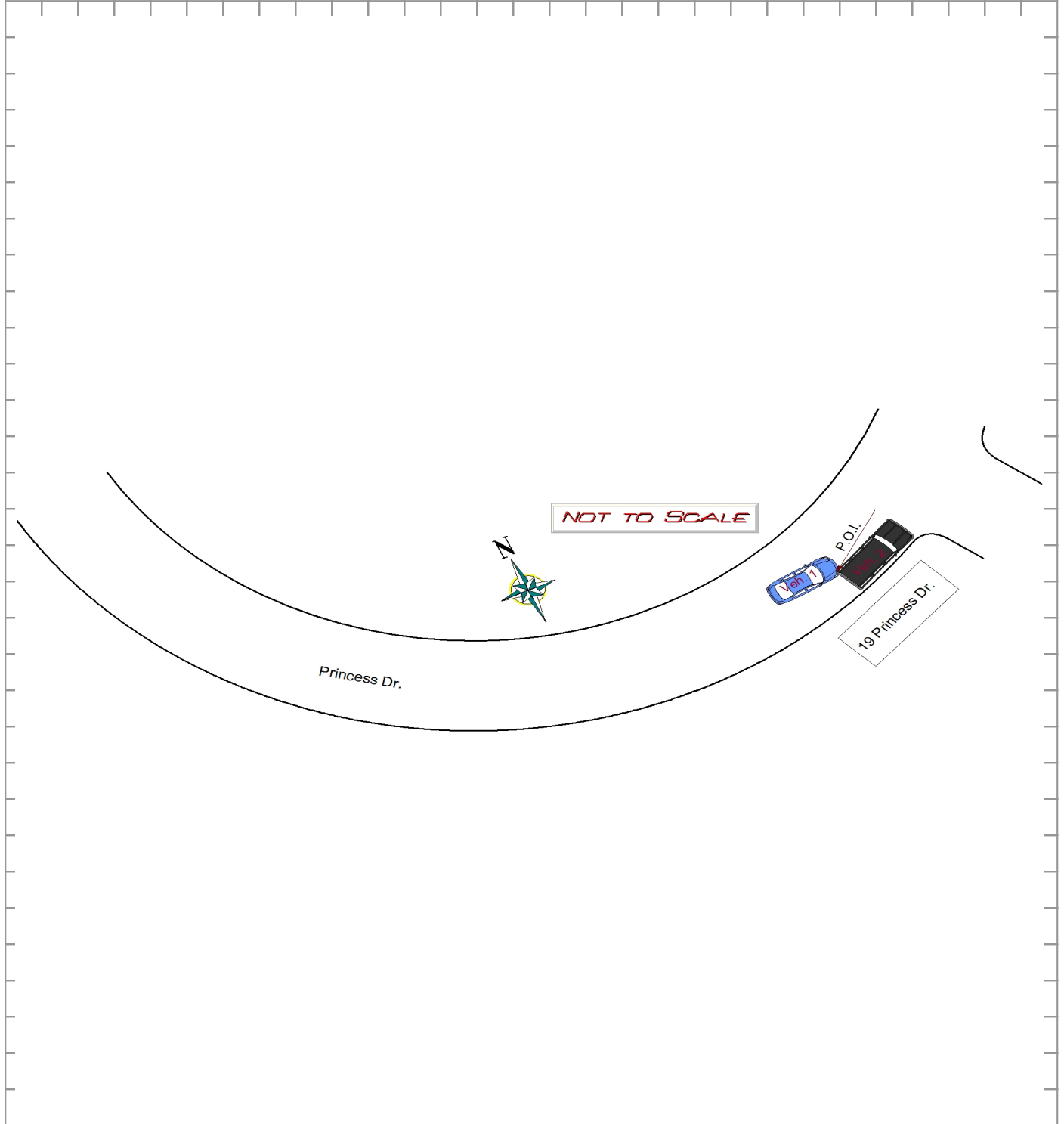
