145. Crash Description/Narrative

Driver 2 stated she was traveling south on Rt.1 in the far right lane slowing for traffic when struck in the rear by vehicle 1. Driver 2 stated after being struck she pulled off the highway into a nearby parking lot however, vehicle 1 did not stop continuing south on Rt.1. Driver 2 described vehicle 1 as a silver colored Jeep Wrangler along with its New Jersey registration G68CWV operated by a white male.

An NCIC check of vehicle 1 registration matched the description given by driver 2 and revealed the address of the registered owner. Officer's responded to the address of vehicle 1 locating the Jeep and registered owner who was identified as driver 1.

Driver 1 stated he was traveling south on Rt.1 in the far right lane when traffic ahead abruptly applied its brakes, not allowing him enough time to stop causing him to strike vehicle 2 in the rear.

Vehicle 1 sustained minor damage to the front bumper, vehicle 2 sustained minor damage to the rear bumper. Driver 2 complained of neck pain however, refused any medical attention.
