145. Crash Description/Narrative

Driver of V1 stated in effect he was traveling eastbound on How Lane when V2, that was behind him in traffic, side-swiped the rear driver's side corner of his vehicle.

Driver of V2 stated in effect that she was traveling eastbound on How Lane going over the bridge when V1 came out of nowhere and hit her.

Investigation revealed V2 caused the collision attempting to pass V1 on the left.

V1 sustained scuff damage to the left rear corner area.

V2 sustained damage to her driver's side mirror.

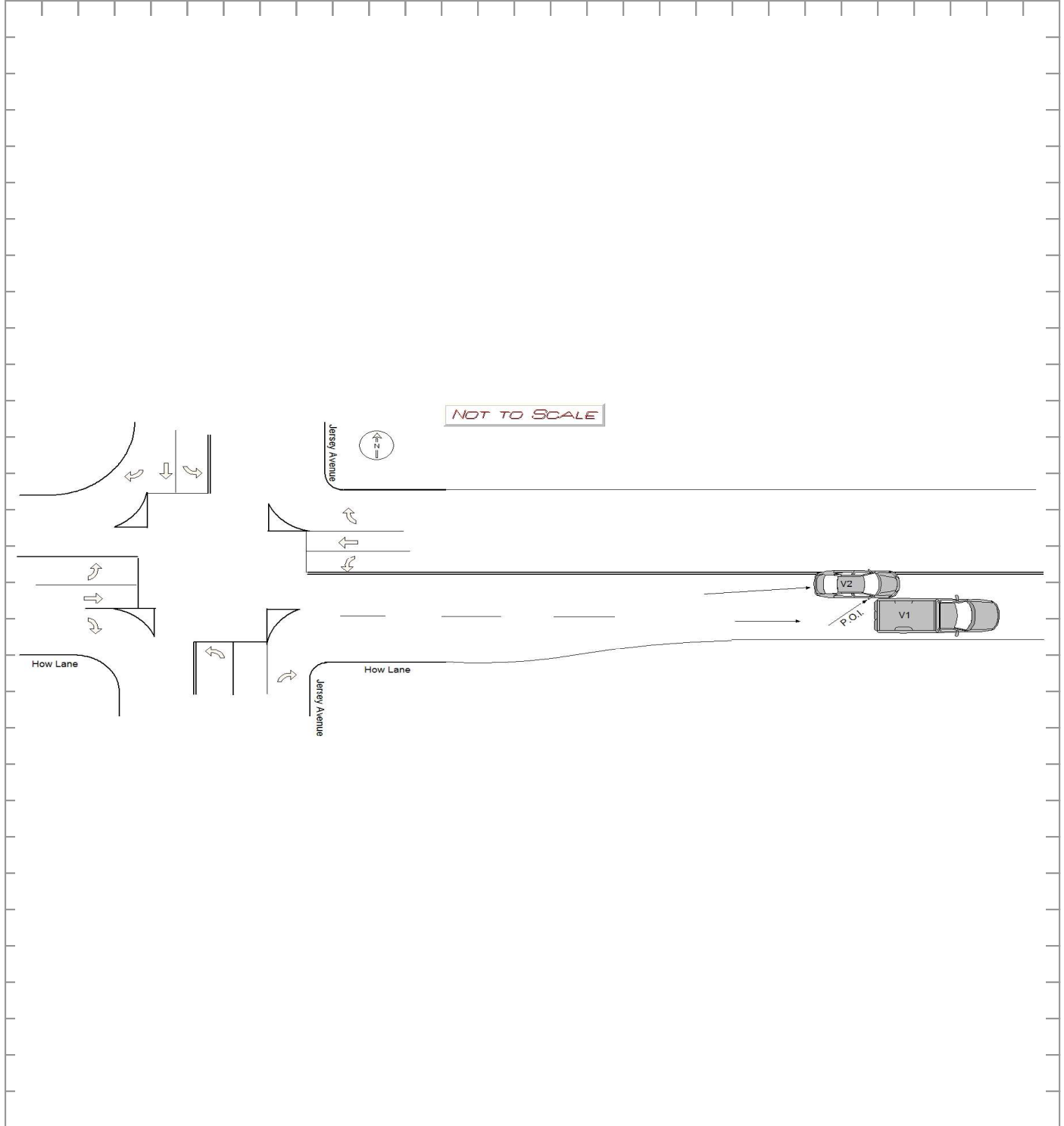
