145. Crash Description/Narrative

V2 stopped at red signal, in left lane of Route 1 South. V1 traveling straight behind V2.

Crash analysis revealed, as V2 was stopped at a red signal, V1 began slowing and at the last minute slamming on his brakes. Causing V1 to skid across the wet roadway. The front of V1 struck the rear of V2 causing minor damages.

V2 advised, she was stopped when she heard the tires of V1 skidding across the roadway.

V1 advised, he was slowing but reacted too late causing him to slam on his brakes.

Upon inspection of V1, I observed one spare tire on the rear driver side which was in good condition, as well good tread depth and adequate tire pressure in the remainder of the tires on V1.

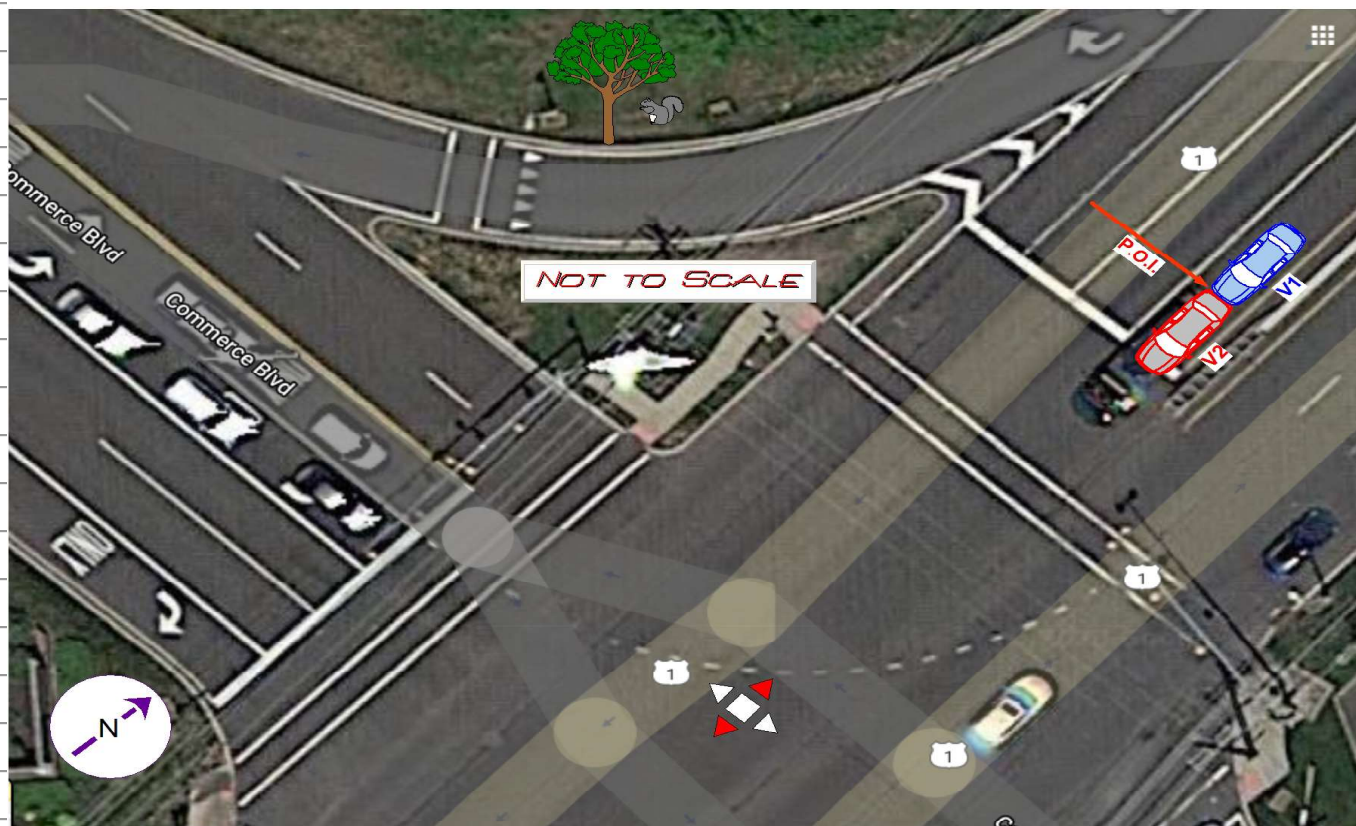
