145. Crash Description/Narrative

Vehicle 3 was stopped in traffic in the left lane on Route 1 Southbound approximately 300 feet south of Elizabeth Street. Vehicle 2 was slowing behind vehicle 3 and vehicle 1 was travelling behind vehicle 2.

Driver 1 stated that when he went to pick up his water bottle, it slipped out of his and fell to his feet. He bent down to pick it up but it rolled under his brake pedal. He then observed that traffic was stopping in front of him, but he was unable to press the brake because the water bottle was stuck underneath the pedal. He then rear ended vehicle 2. Driver 2 stated she was rear ended by vehicle 1 and then pushed into vehicle 2. Vehicle 3 stated she was rear ended by vehicle 2.

I did not observe any skid marks on the roadway, I did however observe a water bottle jammed under the brake pedal of vehicle 1.

Investigation reveals driver 1 rear ended driver 2 because of the water bottle fell and became lodged under the brake pedal of vehicle 1.

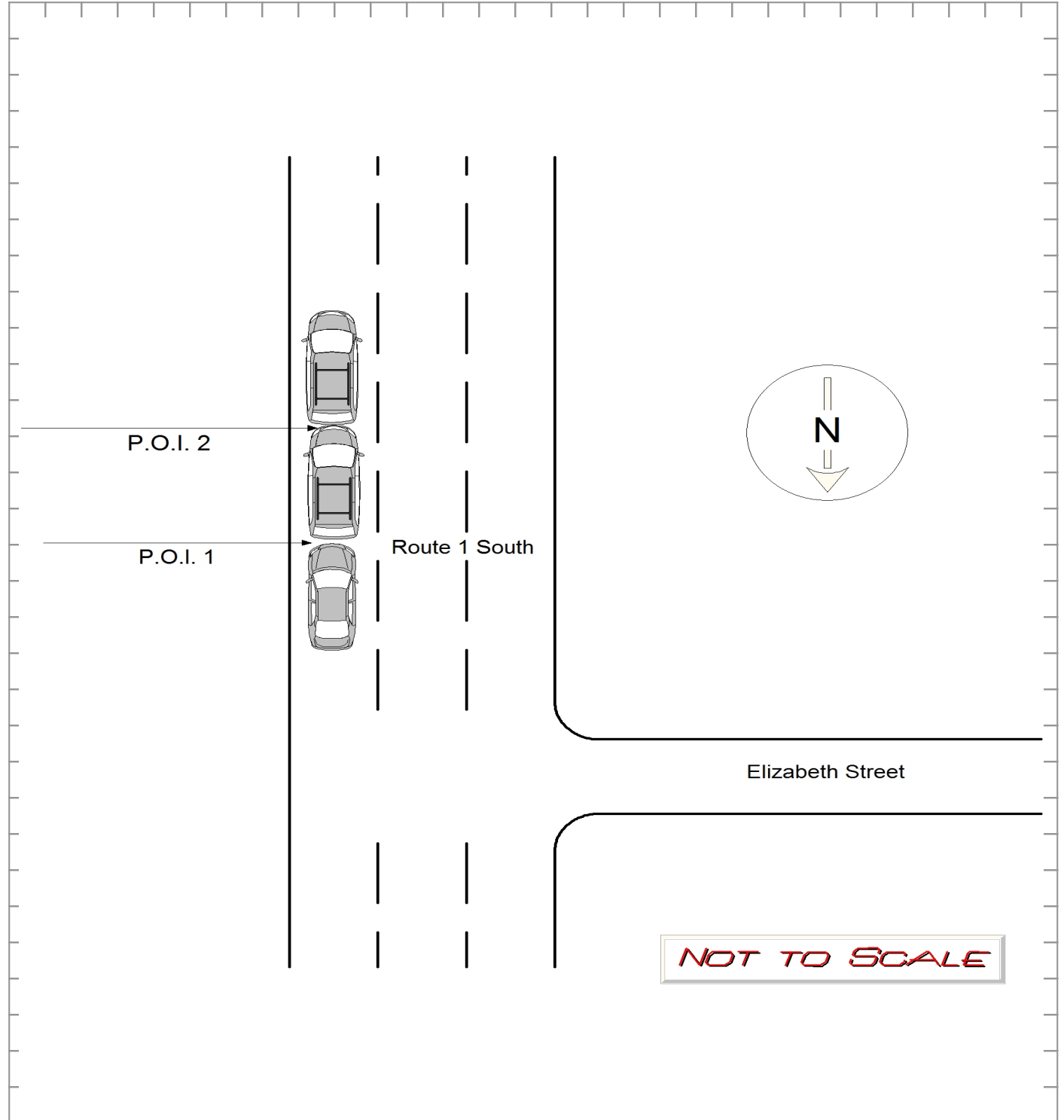
