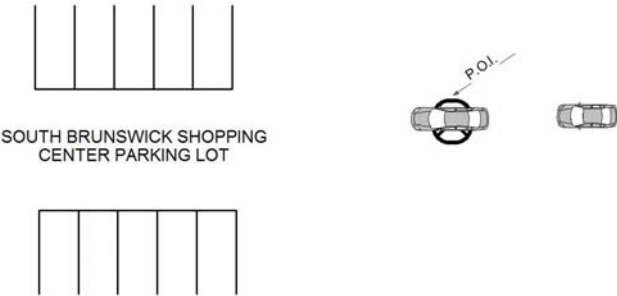
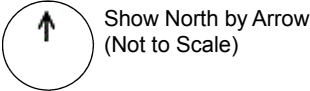

D1 STATED WHILE DRIVING WESTBOUND INSIDE OF THE SOUTH BRUNSWICK SHOPPING CENTER PARKING LOT, HE RAN OVER AN OPEN SEWER MANHOLE AND ITS COVER. D1 STATED THAT THE IMPACT CAUSED DAMAGE TO THE BOTTOM DRIVER SIDE DOOR AND CAUSED DAMAGED UNDERNEATH V1.

WHILE ON SCENE, D1 DID NOT COMPLAIN OF PAIN OR REQUEST MEDICAL ATTENTION. I PLACED THE COVER BACK ONTO THE SEWER. THE SOUTH BRUNSWICK SEWER DEPARTMENT ARRIVED ON SCENE AND PLACED CONES AROUND THE SEWER MANHOLE, THEN MADE THE PROPER NOTIFICATION TO HAVE IT FIXED.
