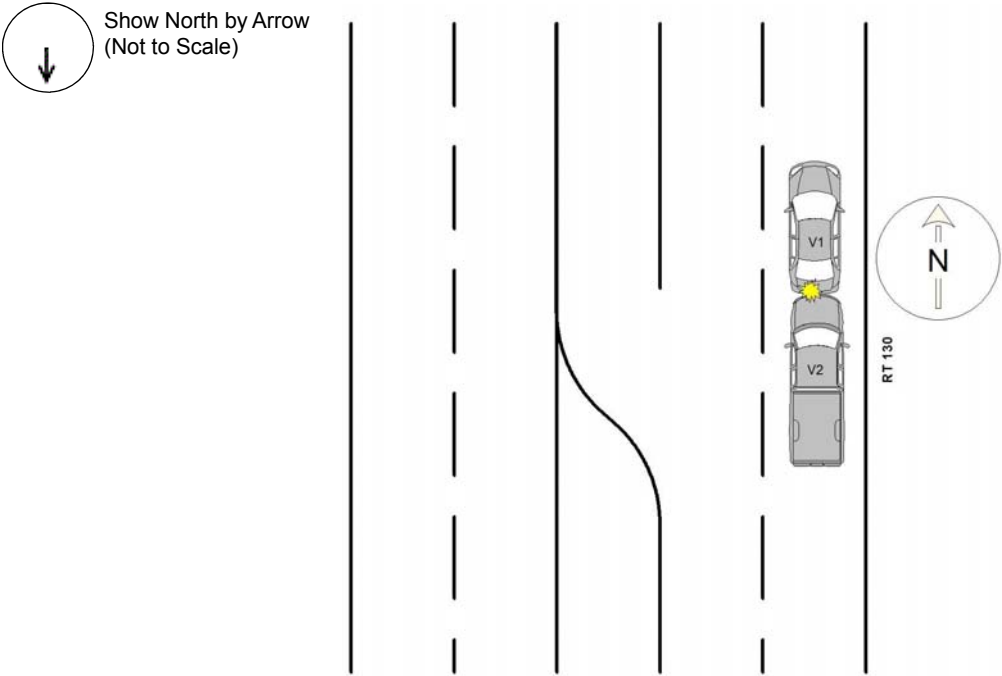

D1 STATED IN EFFECT THAT WHILE STOPPED IN TRAFFIC ON RT 130 NORTH NEAR FRESH PONDS ROAD, V2 IMPACTED THE REAR BUMPER OF V1 CAUSING MINOR DAMAGE.

D2 STATED IN EFFECT THAT WHILE TRAVELING ON RT 130 NORTH NEAR FRESH PONDS ROAD, V1 CAME TO A COMPETE STOP IN FRONT OF HIM. D2 STATED HE TRIED TO AVOID STRIKING V1 BUT WAS UNSUCCESSFUL.
