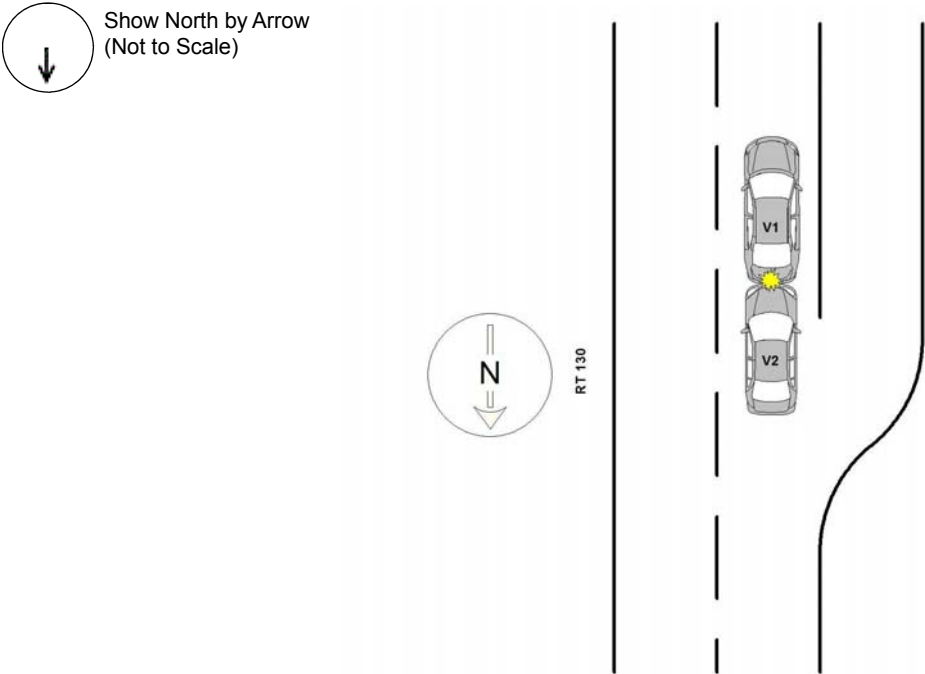

D1 STATED IN EFFECT THAT WHILE STOPPED AT THE TRAFFIC LIGHT ON RT 130 SOUTH NEAR RT 522, V2 IMPACTED THE REAR OF V1 AND CAUSED MINOR DAMAGE TO THE BUMPER.

D2 STATED IN EFFECT THAT WHILE TRAVELING ON RT 130 SOUTH NEAR RT 522, HIS FOOT SLIPPED OFF OF THE BRAKE PEDDLE AND V2 ROLLED INTO V1 CAUSING MINOR DAMAGE TO V1'S BUMPER.
