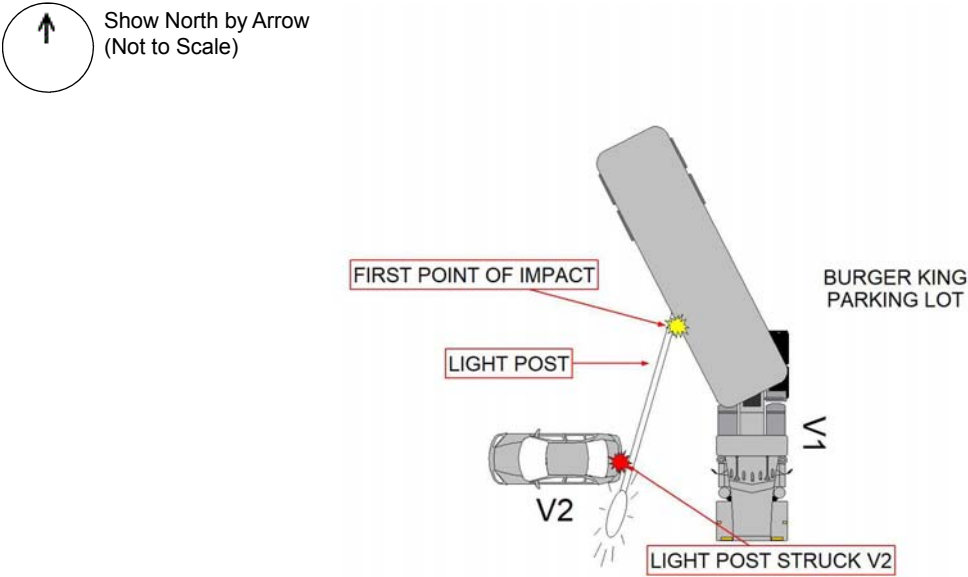

D1 STATED HE WAS MAKING A RIGHT TURN FROM RT.1 NORTH INTO THE BURGER KING PARKING LOT. WHILE MAKING THE TURN THE TRAILER CONNECTED TO V1 STRUCK A LIGHT POLE AND WAS STUCK ON TOP THE CONCRETE BASE OF THE LIGHT POST. WHEN THE LIGHT POST FELL IT STRUCK V2 WHICH WAS PARKED. NO INJURIES WERE REPORTED OR OBSERVED. D1 AT FAULT FOR THE CRASH. GEORGES GARAGE RESPONDED AND REMOVED THE TRAILER FROM THE CONCRETE BASE OF THE LIGHT POST. D1 AT FAULT FOR THE CRASH. MANAGEMENT AT BURGER KING WAS ADVISED TO MAKE PROPER NOTIFICATIONS FOR THE LIGHT POST.
