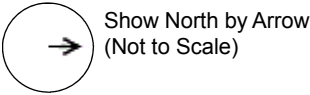


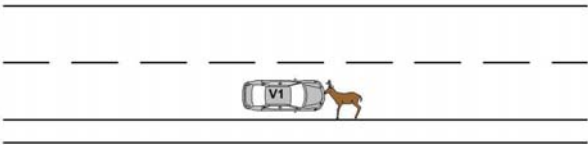

145 Crash Description

D1 STATED IN EFFECT, WHILE TRAVELING NORTH ON STATE ROAD 130, HIS VEHICLE STRUCK A DEER IN THE ROADWAY.

D1 STATED WHILE TRAVELING IN THE RIGHT LANE OF ROUTE 130 NORTH, A DEER RAN OUT IN FRONT OF THE VEHICLE HE WAS OPERATING. D1 STATED HE DID NOT HAVE TIME TO REACT AND ULTIMATELY STRUCK THE DEER WITH THE FRONT END OF THE VEHICLE.

D1 STATED HE DID NOT HAVE ANY INJURIES AT THE TIME OF THE CRASH. V1'S PASSENGER STATED, HER HEAD STRUCK THE VISOR, CAUSING MINOR PAIN AND NOT REQUIRING MEDICAL ATTENTION. V1 WAS DISABLED AS A RESULT OF THE CRASH AND REQUIRED A TOW TRUCK TO REMOVE IT FROM THE ROADWAY. GEORGES GARAGE RESPONDED AND REMOVED THE VEHICLE FROM THE ROADWAY WITHOUT INCIDENT.
