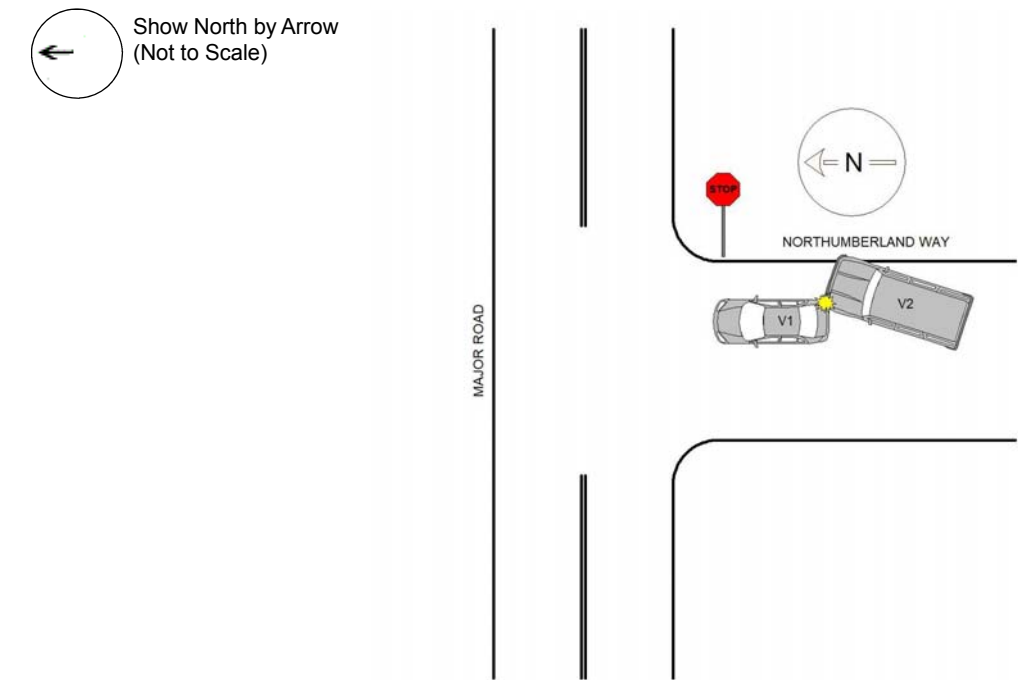

D1 STATED IN EFFECT THAT WHILE STOPPED AT THE THE STOP SIGN ON NORTHUMBERLAND WAY NEAR MAJOR ROAD, V2 IMPACTED THE PASSENGER SIDE OF V1'S REAR BUMPER. CAUSING MINOR DAMAGE.

D2 STATED IN EFFECT THAT WHILE STOPPED BEHIND V1 ON NORTHUMBERLAND WAY NEAR MAJOR ROAD, HER FOOT SLIPPED OFF OF THE BRAKE PEDAL AND V2 ROLLED INTO V1. D2 STATED SHE STEERED TO THE RIGHT TO AVOID STRIKING V1 BUT WAS UNSUCCESSFUL.
