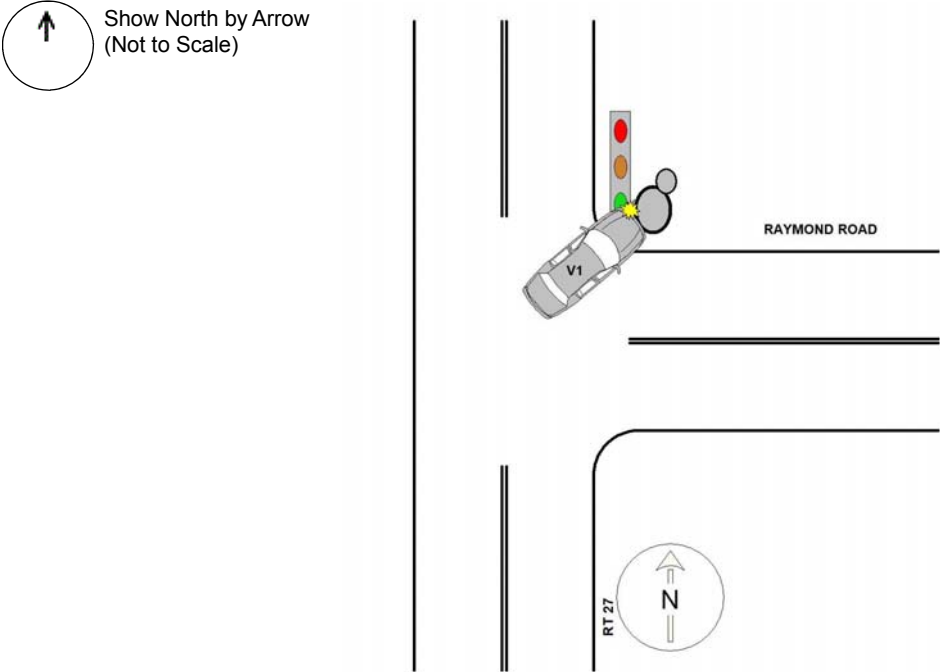

D1 STATED IN EFFECT THAT WHILE TRAVELING ON RT 27 NORTH NEAR RAYMOND ROAD, HE FELL ASLEEP BEHIND THE WHEEL AND WHEN HE WOKE UP V1 WAS HEADING TOWARDS THE UTILITY POLE AND TRAFFIC SIGNAL POLE, ON RAYMOND ROAD AND RT 27. DUE TO THE SLIPPERY ROAD CONDITIONS, D1 STATED HE TRIED APPLYING HIS BRAKES TO STOP V1 BUT WAS UNSUCCESSFUL.

THE UTILITY POLE AND TRAFFIC SIGNAL POLE SUSTAINED HEAVY DAMAGE AS A RESULT OF THE CRASH.

THE PROPER AUTHORITIES WERE CONTACTED TO REPAIR THE DOWN POLES.

NO REPORTED INJURIES.
