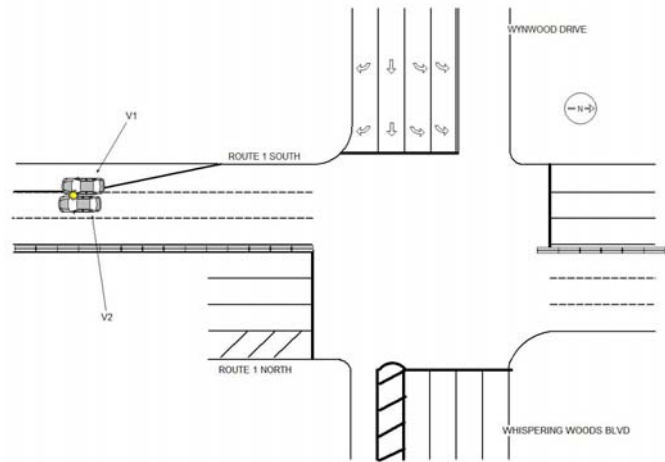
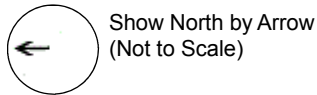

145 Crash Description

DRIVER 1 STATED IN EFFECT THAT HE WAS TRAVELING ON ROUTE 1 SOUTH IN THE SHOULDER OF THE ROADWAY WHEN VEHICLE 2 CAME INTO HIS LANE AND IMPACTED THE SIDE OF HIS VEHICLE. WHEN I ADVISED DRIVER 1 THAT THE SHOULDER OF THE ROADWAY WAS NOT AN ACTIVE LANE ON THE WEEKEND HE CHANGED HIS STORY AND STATED IN EFFECT THAT DURING THE MERGE, VEHICLE 2 CAME INTO HIS LANE AND IMPACTED VEHICLE 1.

DRIVER 2 STATED IN EFFECT THAT SHE WAS DRIVING SOUTHBOUND ON ROUTE 1 WHEN VEHICLE 1 IMPACTED THE SIDE OF VEHICLE 2.

NO INJURIES REPORTED AND NO TOWS NECESSARY.
