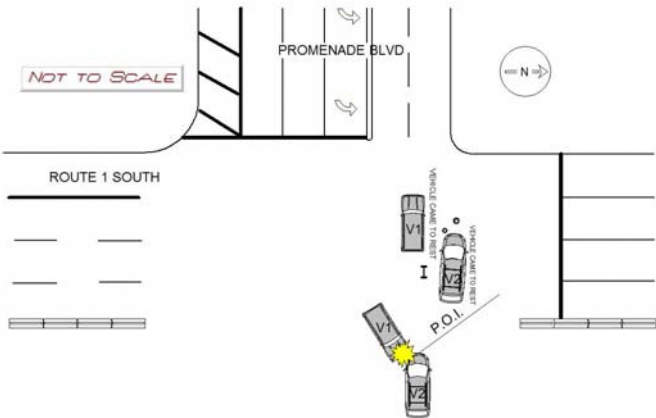

145 Crash Description

DRIVER #1 STATED HE WAS TRAVELING EAST ACROSS ROUTE 1 (PROMENADE BLVD TO ROUTE 522) WHEN VEHICLE #2 TURNED AND CRASHED INTO HIS VEHICLE.

DRIVER #2 STATED HE WAS TRAVELING WEST ACROSS ROUTE 1 (ROUTE 522 TO PROMENADE BLVD) WHEN VEHICLE #1 TURNED LEFT AND CRASHED INTO HIS VEHICLE.

WHILE ON SCENE DRIVER #1 COMPLAINED OF FACE PAIN, DRIVER #2 COMPLAINED OF HEAD PAIN AND THE PASSENGER OF VEHICLE #2 COMPLAINED OF STOMACH PAIN. EMS ARRIVED AND ALL INDIVIDUALS REFUSED MEDICAL ATTENTION.

I OBSERVED DISABLING DAMAGE TO THE DRIVER SIDE FRONT BUMPER AND TIRE AREA OF VEHICLE# 1 AND DISABLING DAMAGE TO THE FRONT CENTER AREA OF VEHICLE #2'S BUMPER.

DUE TO WHERE THE VEHICLES CAME TO REST AND THE DEBRIS FROM THE ACCIDENTS ALONG WITH THE DAMAGE TO THE VEHICLES, I DETERMINED THAT VEHICLE #1 WAS ATTEMPTING TO TURN LEFT ONTO ROUTE 1 NORTHBOUND FROM PROMENADE BLVD AND HE CRASHED INTO VEHICLE #2. VEHICLE #2 WAS TRAVELING EAST ONTO PROMENADE BLVD FROM ROUTE 522.

I FOUND DRIVER #1 AT FAULT FOR THE CRASH.
